# Update: weekend works to install tower crane


## Scaffold install during weekend working hours – 16 April

We recently informed you, we will install a tower crane in Euston Throat worksite during the weekend 23 to 24 April (Tower Crane B).

The tower crane will sit on top of a large frame, above our future haul route. For safety, we must install an anti-trespass scaffold around this base frame, before we install the tower crane.

For safety, we need to install this scaffold when there are no other works nearby. We will install the scaffold on Saturday 16 April during extended weekend working hours from 8am to 6pm, before we install the tower crane the following weekend. Our team will use hand tools to construct the scaffold and we do not expect these works to be noisy.
