Notice of temporary closure on B4455 Fosse Way in Offchurch

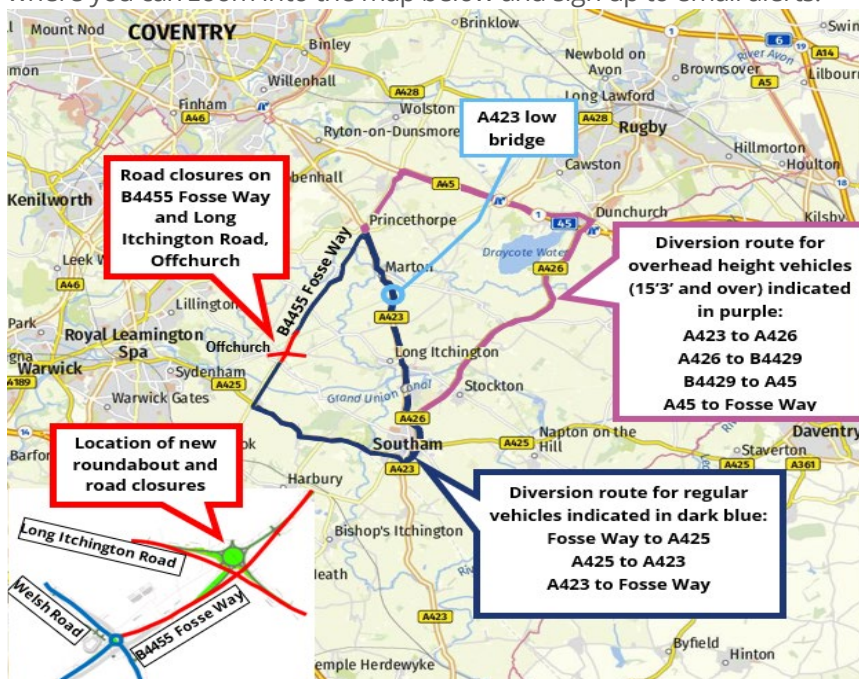
Notification



High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are underway in your area, carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

This is an update providing notice that the **Fosse Way B4455, Offchurch, Warwickshire is due to be closed 24 hours a day, 7 days a week from Friday 29 April until the end of May 2022.** The road closure is needed to finish building a new roundabout at the junction of the Fosse Way and Long Itchington Road. The roundabout will keep everyone moving safely through the area during HS2 construction. Long Itchington Road will remain closed between Snowford Hill and Welsh Road until early June. Access for cyclists via Cycle Route 41 will be maintained but may be diverted depending on where we are working. Balfour Beatty Vinci will be closing Rugby Road between Cubbington and Weston under Wetherley, 9:30am to 3:30pm on 23 May to 1 June.

Duration of work

Fosse Way closed 29 April until end of May 2022.

Long Itchington Road closed until early June 2022. Access for cyclists via National Cycle Route 41 is maintained.

Our working hours

7 day working during the road closure period (working hours may vary).

Some noise from machinery.

Keep disruptions to a minimum.

Maintain access to properties, and for emergency services.
