High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

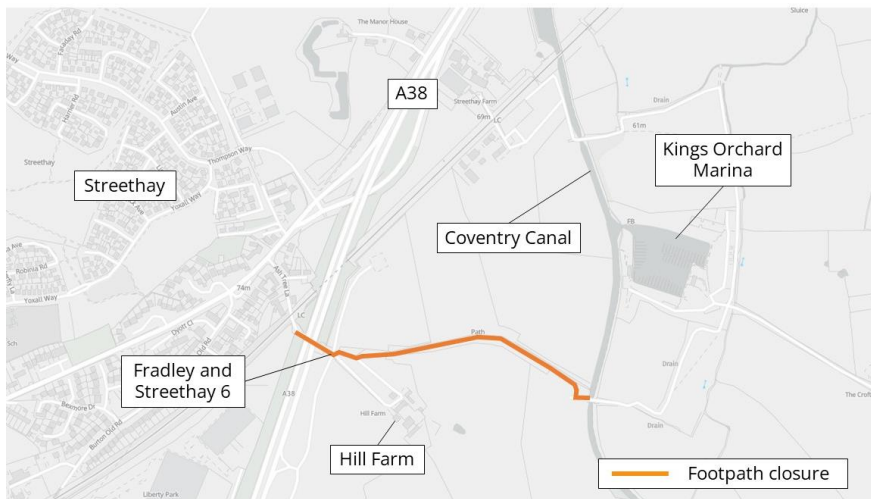
The work we will be doing

During the parliamentary stages we identified ways to reduce the visual impact of the scheme, we responded to concerns and the design within the Streethay area was changed to a cutting. This will take HS2 out of the line of sight within Streethay, Lichfield.

To support this and ensure the safety of the public, we will be closing Public Right of Way Fradley and Streethay 6 for the duration of our construction period. This is expected to be in place for a minimum of four years, before a safe route can be re-established.

The closure will be in place from Tuesday 3 May

The footpath closure has been marked in orange on the map below. At the point of closure, there is no through route.
