

# Notice of trial holes on Old Oak Common Lane

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

As part of the wider site infrastructure works at the Old Oak Common station site, we will be digging a deep trial pit (hole) along the northbound carriageway of Old Oak Common Lane. This will be filled back in after the work has been completed. The purpose of the trial pit is to locate existing services underground.

## Excavations on Old Oak Common Lane

This work will take place within the current lane closure during our working hours of 8am to 6pm Monday to Friday. Noisy work will only take place between 9am and 5pm.

Activities include digging a hole with an excavator and then hand digging around the live services. The excavated materials will be transported offsite by lorry. Once the hole has been backfilled tarmac will be rolled over the top to flatten the surface.

As there will be some noise associated with this work, it is not expected to be disruptive and this will only take place between 9am and 5pm. We will be using acoustic blankets along the fences and the work to minimise noise.

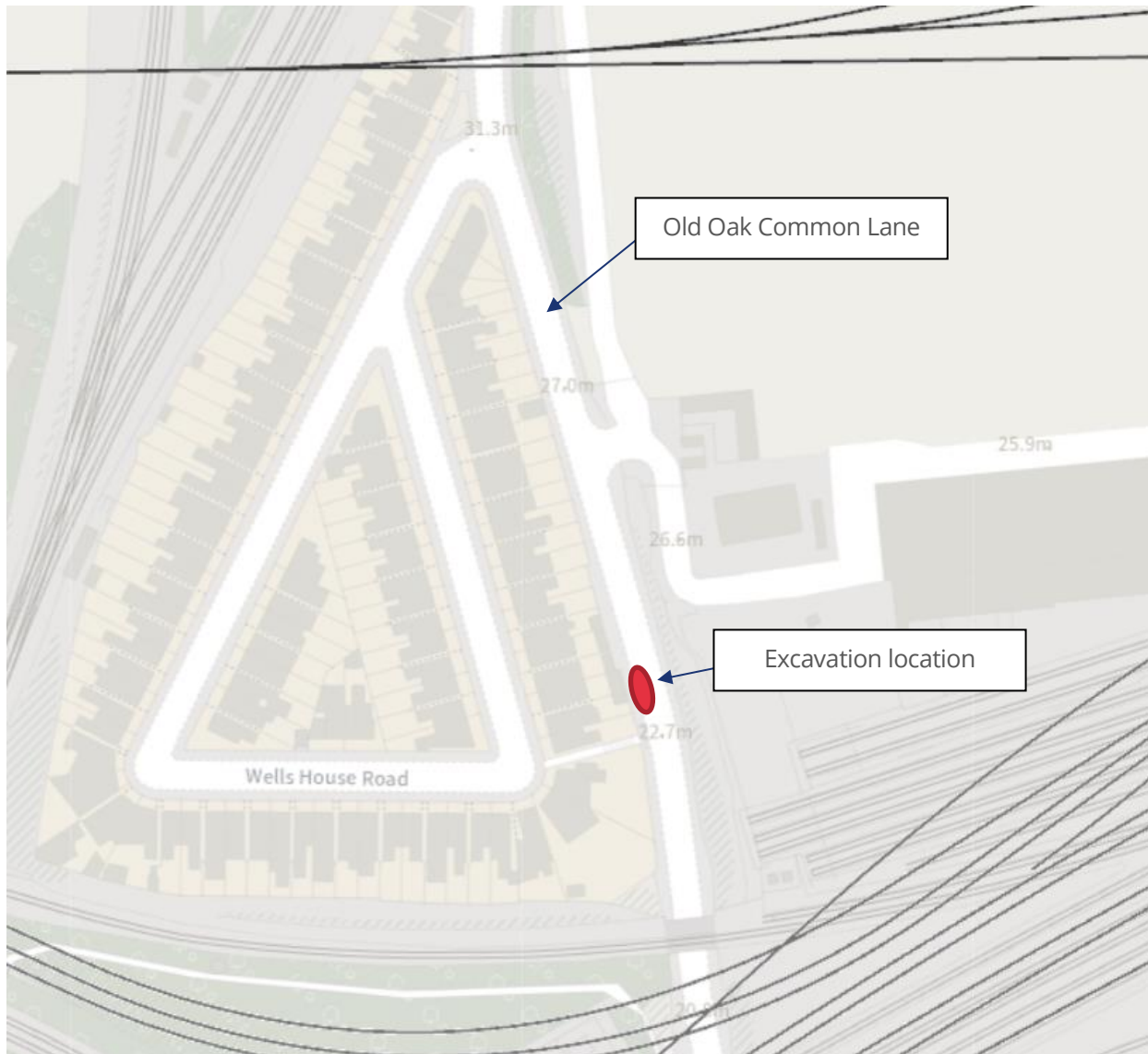
