



Notice of hedge trimming works on Chorlton Lane and Waybutt Lane, Chorlton

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out Early Environmental works between Lichfield and Crewe.

What we are doing

We will be creating ecological mitigation ponds surrounded by grassland habitat creation on land to the south of Chorlton Lane and west of Waybutt Lane. We will use the ponds to relocate any protected species such as great crested newts before we need to remove any other habitats.

We will be carrying out hedge trimming to the boundary of the site along both Chorlton Lane and Waybutt Lane so as to increase visibility and make sure that they do not overhang into the road. To do this we will put signs to warn road users that hedge trimming is taking place.

Once we finish hedge trimming, we will begin to excavate some archaeological trial trenches. These are to help us understand if there are any archaeological features or natural geological deposits, that we need to be aware of before we start any other work.

We will be using a slow-moving tractor and flail to carry out the hedge trimming

When the work take place?

We will start the hedge cutting works on 6 April and it is expected to take one day. We will begin work to create the ponds themselves once we have carried out the archaeological work, the pond work will be ongoing throughout the year.

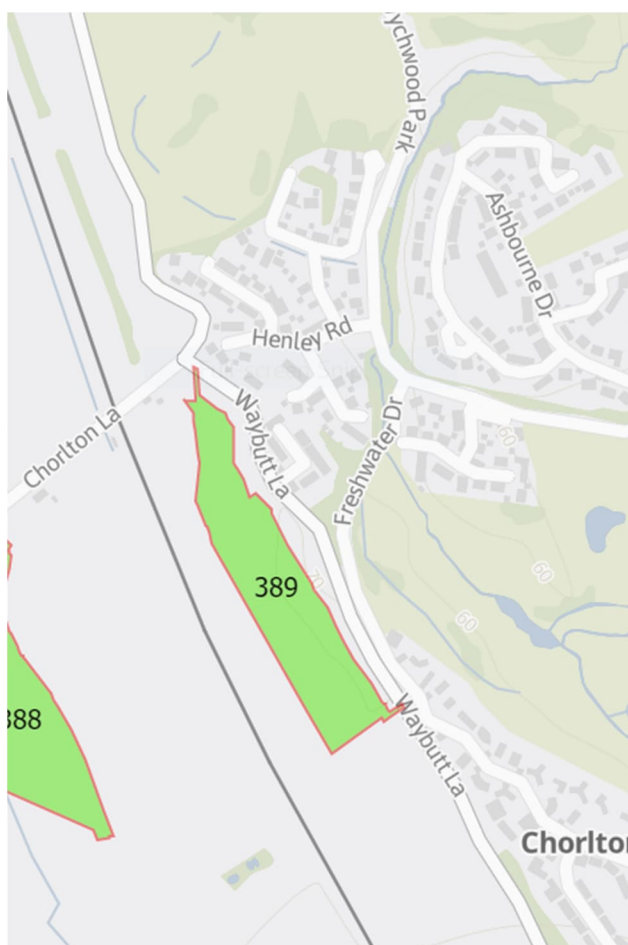

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
