



Notice of final landscaping works on Bottom House Farm Lane

High Speed Two (HS2) is the new high speed railway for Britain. Following the landscaping earlier this year on Bottom House Farm Lane, the completion of these works will take place this month.

What works are taking place?

Earlier this year landscaping and hedge planting took place along Bottom House Farm Lane. The areas with new soil now need to be sowed with grass seed. These works will take place over three days starting Monday 11 April.

The works will involve the spreading of grass seed, which will then be raked in. To protect staff on site from moving vehicles, areas where they are working will be coned off. However Bottom House Farm Lane will remain open to traffic. Vehicles will be managed around the works. Below is a map showing the extent of the works between the River Misbourne bridge and Upper Bottom House Farm.

Monday 11 to Friday 15 April – 8am to 5pm with one hour's set and shut down outside of those times

Traffic management along the lane whilst the works are taking place. This will be in the form of coned off areas. Bottom House Farm Lane will be open for through traffic
