High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. The health and safety of our workforce and the communities we work within is our priority. If you have any questions about this, please contact our Helpdesk to find out more. What are we doing?

In May, we will be carrying out Ground Investigation (GI) works along Station Road.

Our GI works will involve surveys and trial holes. These activities will allow us to accurately identify the location of utilities that will need to be diverted while we build HS2.

As we will be conducting these surveys and trial holes very close to the local highway, we will need to close small sections of Station Road.

To avoid closing all of Station Road and maintain access to local businesses, we will be conducting these works over two separate weekends. Access to local businesses and the Buckinghamshire Railway Centre will be maintained with a local diversion route signposted.

When will these works take place?

A section of Station Road will be closed for Ground Investigation works on the following dates:

- Saturday 21 May and Sunday 22 May, 8.00am to 6.00pm
- Saturday 28 May and Sunday 29 May, 8.00am to 6.00pm

In the coming weeks, we will also be carrying out further utility works and surveys along additional sections of Station Road. Once these details have been confirmed we will update communities.
