

Notice of sewer survey works at Hanchurch Interchange (M6 junction 15/A500)

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Balfour Beatty is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

To complete the detailed design for the proposed footbridge over the A500, we need to understand the position of a pressurised sewer pipe that runs parallel to the A500. To do this, we will insert a probe through the pressurised pipe so we can trace it from ground level. We do not need to close the sewer so there will be no changes to residents' private utilities.

We will access the pipe through the Severn Trent compound and will need to drill an opening into it to insert the probe. While we do this there will be some noise, but this will only be for a short period of time. To minimise disruption to residents, we will carry out this work during the day.

When we are working

We will carry out the work on Tuesday 3 May 2022.

It is likely that our contractors won't need the whole time to complete this work. The hours indicated are to allow for any unforeseen delays.

Please note that if we are unable to complete the work on the pipe connection, we will return the following day.

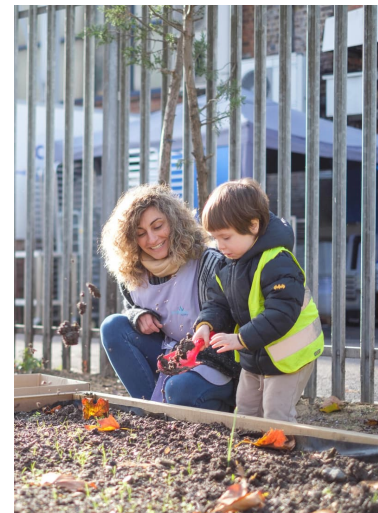
About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
