High Speed Two (HS2) is the new high-speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work will we be doing

So that our vehicles don't cause damage to the road we will be making improvements to the road surface by installing a plant crossing on Rugby Road, this will allow the use of our haul road in this area. Haul roads are temporary roads provided within a working area to allow for the movement of construction materials, construction machinery and/or construction staff around the site. Haul roads are Balfour Beatty Vinci's preferred logistical transport link, as they reduce the number of vehicle movements interfering with the existing local road network and provide the greatest possible control over works activity.

When these works will take place

To allow us to carry out these works safely, two-way traffic lights will be in place 24 hours a day, seven days a week from **Monday 2 May** until **Friday 20 May**, this will be followed by a total closure from **Monday 23 May** to **Wednesday 1 June**. The closure will be in place from **9.30am** to **3.30pm** on weekdays, reverting to traffic light control outside of these hours.

Access will be maintained to all properties while these works are being carried out.

A fully signed diversion will be in place as required during these works.

Please note, Fosse Way will also be closed from 30 April to end of May.

Duration of works

- Traffic lights will be in place 24 hours a day seven days a week from **Monday 2 May** to **Friday 20 May** followed by a weekday off-peak closure (9.30am-3.30pm) **Monday 23 May** to **Wednesday 1 June** reverting to traffic light control outside of these hours.
- Access to all properties will be maintained during these works.

What to expected

- Some disruption to travel times.
- Our workforce can be on site one hour before and one hour after to set up and secure equipment.
- Low levels of noise.
- A fully signed diversion as required.

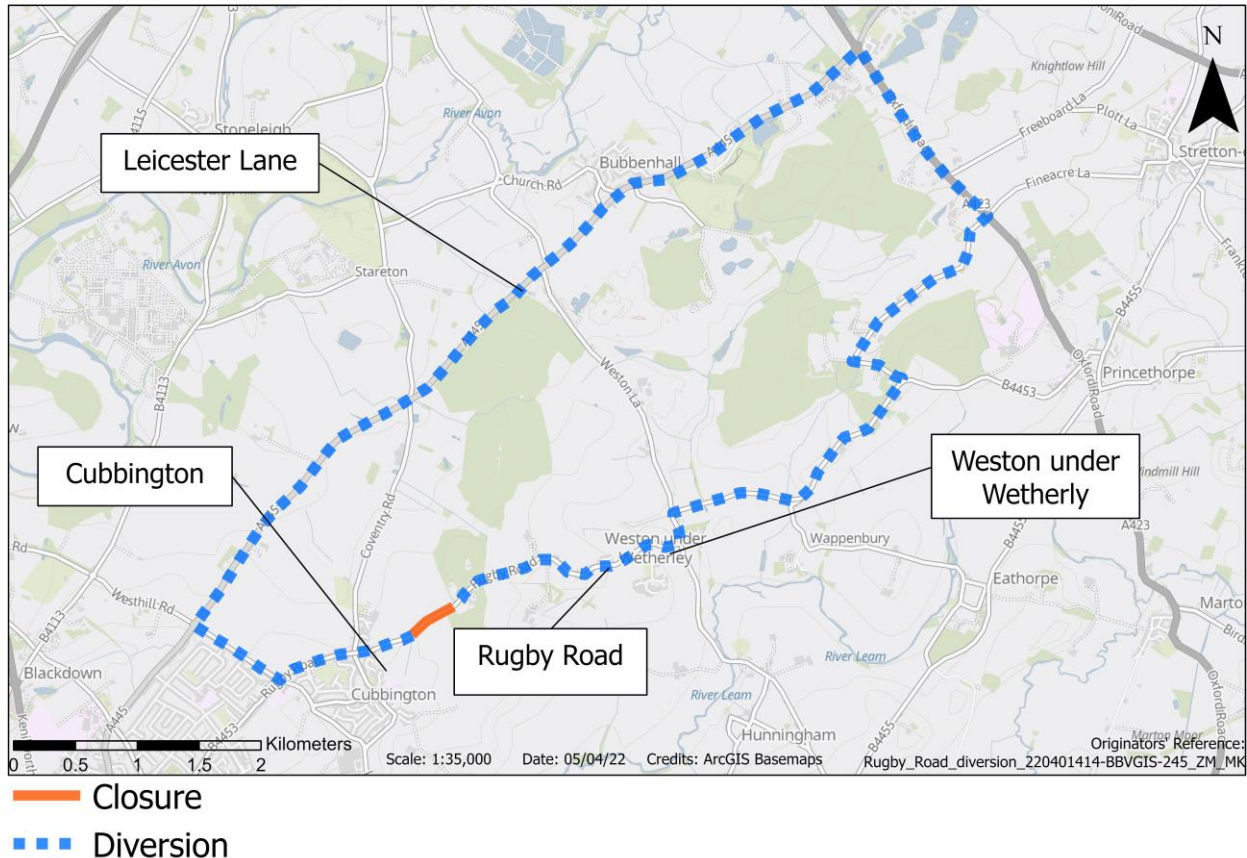
