What we are doing

We wrote to you in April to let you know that we would be carrying out drainage survey works on Old Dairy Lane on 10 and 11 May 2022. However, these works did not go ahead as planned and have now been rescheduled to take place on 5 and 6 July 2022.

Overnight on 5 and 6 July 2022, we will be carrying out drainage surveys on Old Dairy Lane. The surveys will involve the use of CCTV cameras and scanning equipment in the area shown on the map overleaf.

How these works might affect you

Temporary traffic management of a single lane closure, safety zones and clearly signed road diversions will be in place to ensure the surveys are carried out safely.

We would like to apologise in advance for the disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.

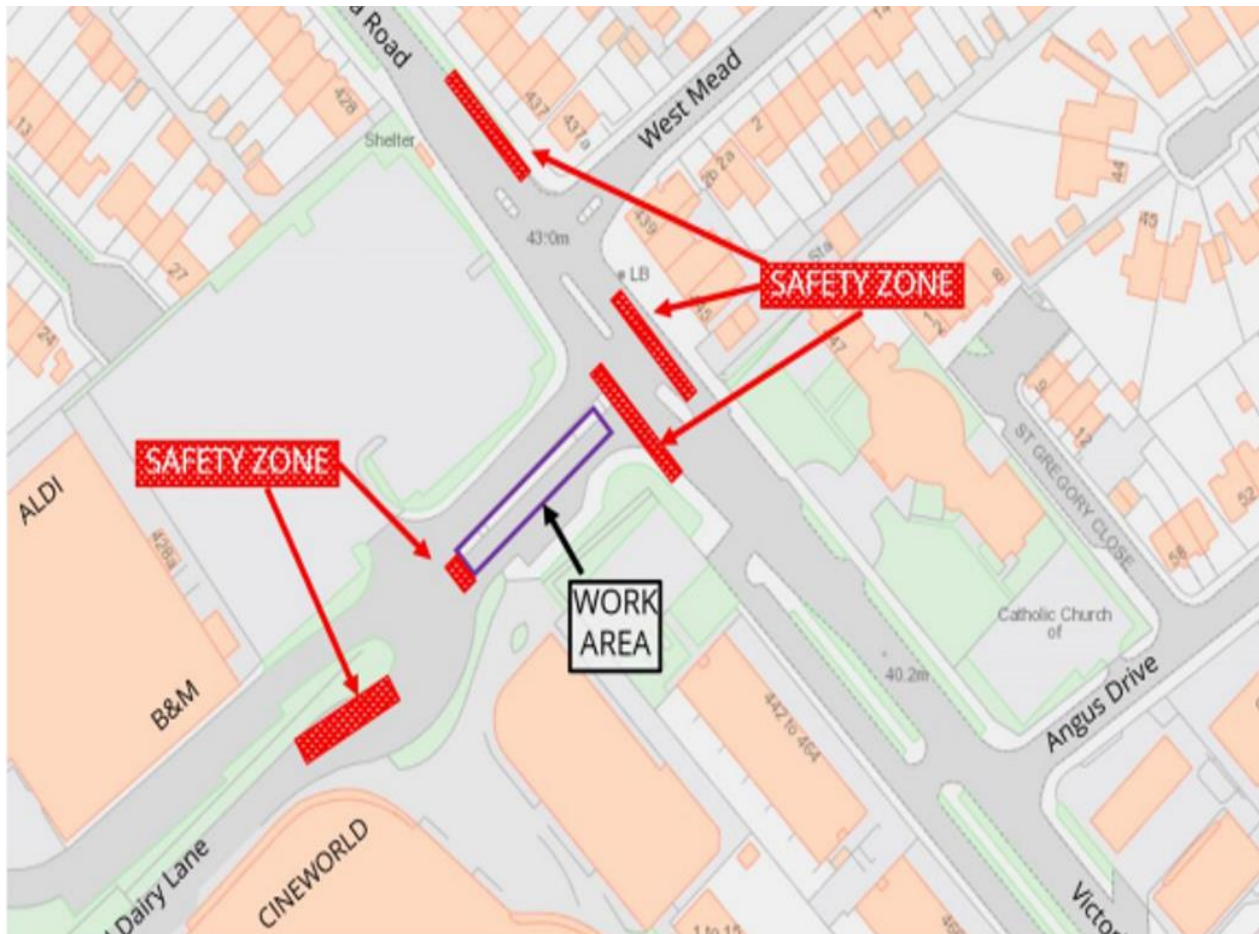
