

# Update notice of utility works, Calvert

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. ## What are we doing?

In February 2022, we advised you of our continuing works in your area in relation to the utility diversion works along Werner Terrace and Brackley Lane, Calvert. BT – Gigaclear and Anglian Water have now completed their utility diversion works within the highway.

## Brackley Lane

As part of the final utility diversion works, the existing pole mounted substation on Brackley Lane needs to be replaced ahead of Western Power Distribution making their new utility connections.

The new GRP (Glass reinforced plastic) unit will be 3m x 2.5m and installed on a concrete plinth, once completed and for health and safety purposes it will be locally surrounded by a timber fence.

For this work, we will need to install 3-way temporary traffic lights on Brackley Lane at the junction of Cotswolds Way from:

**Late April/ early May to the end of May 2022 (Subject to final consents and approval)**

The 3-way temporary traffic lights will be operational 24/7 during this phase of the work. Throughout this works, there will be reduced restricted residential parking on the highway (please see map enclosed).

Restricted residential parking

24/7 traffic lights on the junction of Brackley Lane and Werner Terrace from late April to early July 2022 (Subject to final consents and approval)

Restricted residential parking

24/7 traffic lights on Calvert Road from late April to early July 2022 (Subject to final consents and approval)

Work hard to ensure any impacts to residents are kept to a minimum during these works.

## What are we doing continued?

### Brackley Lane – continuation

Whilst the temporary traffic lights are in place on Brackley Lane and Cotswolds Way, we will continue our demobilisation works from site, where we will remove all plant, materials and reinstate the areas where we have been working. We will continue to remove the two temporary bell mouth highway entrances on Brackley Lane and reinstate the highway.

### Junction of Brackley Lane and Werner Terrace

As part of the utility diversion works, WPD need to connect their existing services to the newly diverted cables. To do this safely, they will need to install 3-way temporary traffic lights on the junction of Brackley Lane and Werner Terrace.

The 3-way temporary traffic lights will be installed on the junction with Brackley Lane and Werner Terrace and will only be **operational over a ten day period from late April to early July 2022 (Subject to final consents and approval)**

The 3- way temporary traffic lights will be operational 24/7 during this section of work.

Throughout these works, there will be a reduced restricted residential parking on Werner Terrace and Brackley Lane junction (please see map enclosed).

The public bus stop on Werner Terrace will be suspended whilst we undertake the utility connection and diversion works.

During the utility diversion works, the temporary traffic lights at Brackley Lane, Cotswolds Way and Brackley Lane junction of Werner Terrace will not be operating at the same time.

Ahead of the works taking place, advanced signage will be erected on the highway, advising when the traffic lights will be in operation.

**You will be contacted directly by your utility supplier if there are any outages to your supply.**

### Calvert Road

To enable WPD to connect their existing services to the newly diverted cables, they will need to install 2-way temporary traffic lights 24/7 on Calvert Road. The temporary traffic lights will only be **operational over a ten day period from late April to early July 2022 (Subject to final consents and approval)**

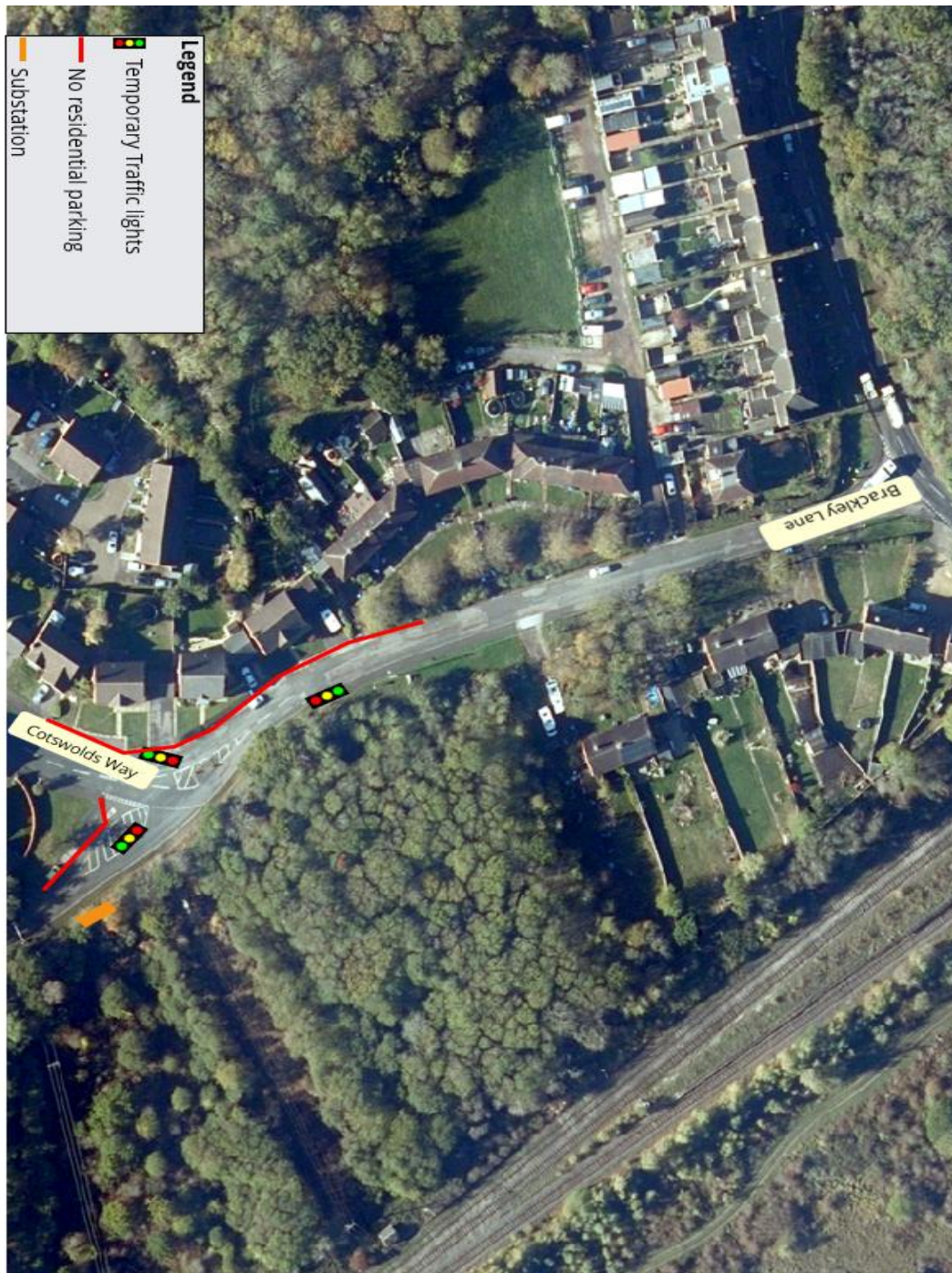
