Update on construction at South Ruislip ventilation shaft site

High Speed Two (HS2) is the new high speed railway for Britain.

We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. What we are doing

We wrote to you in January 2022, to update you on the construction of the ventilation shaft at South Ruislip.

From 4 April to 10 June 2022, we will be installing sheet piling, bored piling and capping beams as part of our work to reinforce the vent shafts and create the foundations for the headhouse.

Sheet piling will be installed between 8am and 6pm Monday to Friday.

The bored piling and capping beam work will occur 24 hours a day, Monday to Friday and 8am to 8pm Saturdays.

From 11 April to 23 May 2022 we will be demobilising the large cranes and excavators. You may notice these abnormal loads being removed from site during early mornings and late at night to avoid congestion on local roads.

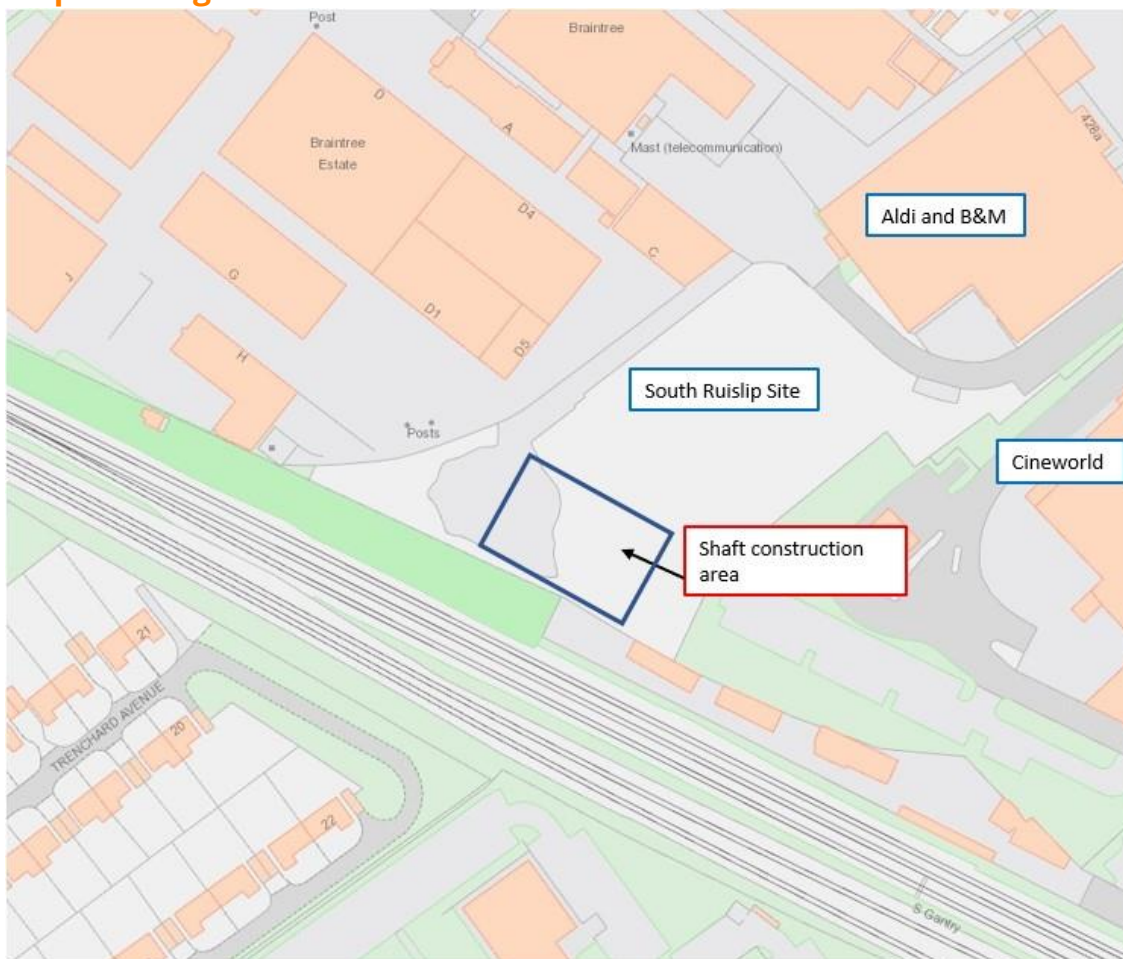
