High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

Utility works on New Bartholomew Street

We will be carrying out works on **New Bartholomew Street**, as we continue utility diversions in preparation for the construction of the railway. To carry out these works, we will need to manage traffic in the local area, this will include a temporary lane closure, managed by temporary traffic lights and pedestrian management.

What to expect

Temporary single lane closure on New Bartholomew Street

Traffic and pedestrian management measures will be in place as we carry out the works.

Core working hours are 8am to 6pm, although staff may be on site up to an hour before and an hour after those times.

What we will do

Clearly signpost the lane closure and pedestrian management and explain these changes to road users and pedestrians.
