High Speed Two (HS2) is the new high speed railway for Britain.

We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. Vehicle Holding Area to receive lorries from 7.30am

We will start opening the Vehicle Holding Area on Prince Albert Road at 7.30am each morning, to prevent construction vehicles parking on local streets while they wait to enter site.

Standard operating hours for the Vehicle Holding Area will be Monday to Friday 7.30am to 6pm and Saturday 7.30am to 1pm.

We will be on site for an hour before the start and/or end of each shift for site set up and tidying up of the site at the end of the day.

Sometimes we may need to extend operating hours at the Vehicle Holding Area, to support extended hour works in the Euston Approach worksites. We apologise for any disruption this may cause.
