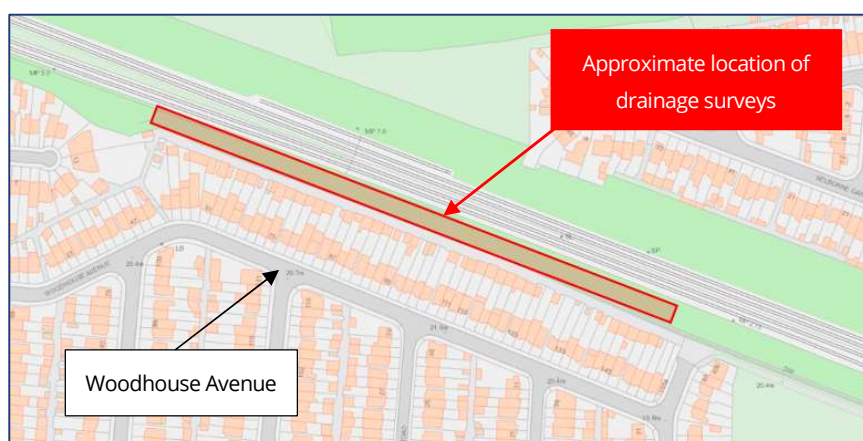
Surveys planned on Woodhouse Avenue

We wrote to you last month about drainage surveys on the private road behind the properties on Woodhouse Avenue. The surveys were planned to take place from 25 to 28 April 2022.

The surveys will now take place during the day from 17 to 20 May 2022 between 8am and 6pm. These surveys will help us to understand the condition of the drainage system in the area and how best to protect them during the construction of the railway. Access to the gated area has been agreed with a local resident representative.
