High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Traffic management update

Due to excavation works next to the A46 southbound, including the installation of a temporary barrier to protect the excavation itself, the A46 slip road will be closed to all traffic, for a period of 4 or 5 consecutive nights, over a period of 4 weeks, whilst this work takes place.

Overnight closures will be in place from 8pm until 6am on the following dates:

Monday 13 June 2022 to Thursday 16 June 2022

Monday 20 June 2022 to Thursday 24 June 2022

Tuesday 28 June 2022 to Friday 1 July 2022

Monday 4 July 2022 to Friday 8 July 2022

While the closure is in place a diversion will be in operation. Please see map overleaf for details.

Duration of works

The A46 slip road will be closed to all traffic, for a period of 4 or 5 consecutive nights, over a period of 4 weeks.

These works will take place during specific dates and times from **Monday 13 June to Friday 8 July**.

Closures will be in place overnight from 8pm to 6am.

Our workforce may be on-site one hour before and one hour after to set up and secure our equipment.

Some limited disruption to travel times.

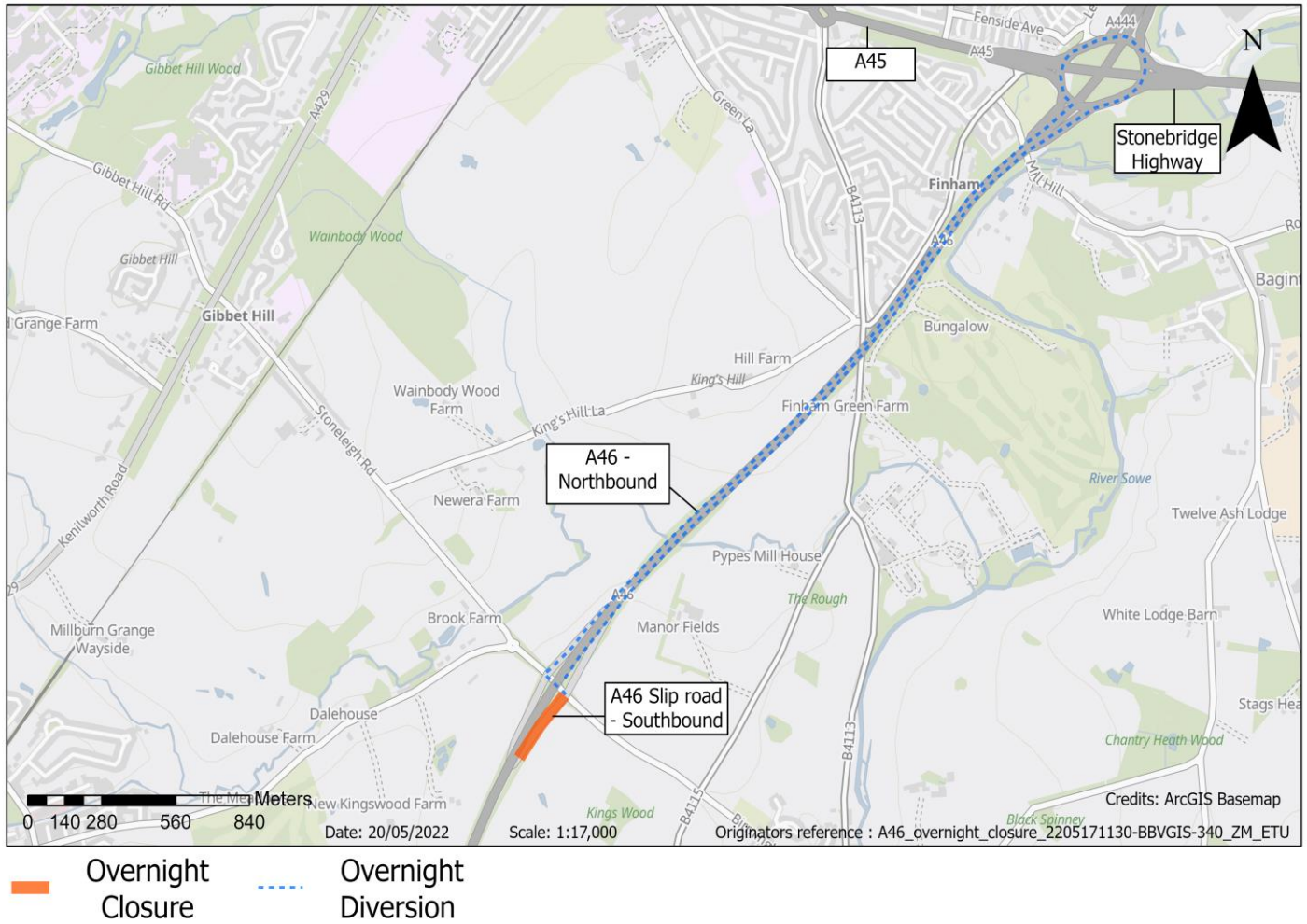
Fully signposted diversion will be in place.
