



Notice of traffic management at Ashow Road (B4115) crossroads, Stoneleigh

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Traffic management update

Due to the increased traffic in the area, it is necessary to install permanent traffic lights at the junction of **Ashow Road, Stoneleigh Road** and **Birmingham Road**. To complete this work safely we need to install temporary traffic management as shown below.

Duration of works

Four-way temporary traffic lights will be in place at the junction from: **Monday 13 June to Friday 8 July**,

(Please see map below).

Our workforce may be on site one hour before and one hour after to set up and secure our equipment.

Access to properties will be maintained throughout.

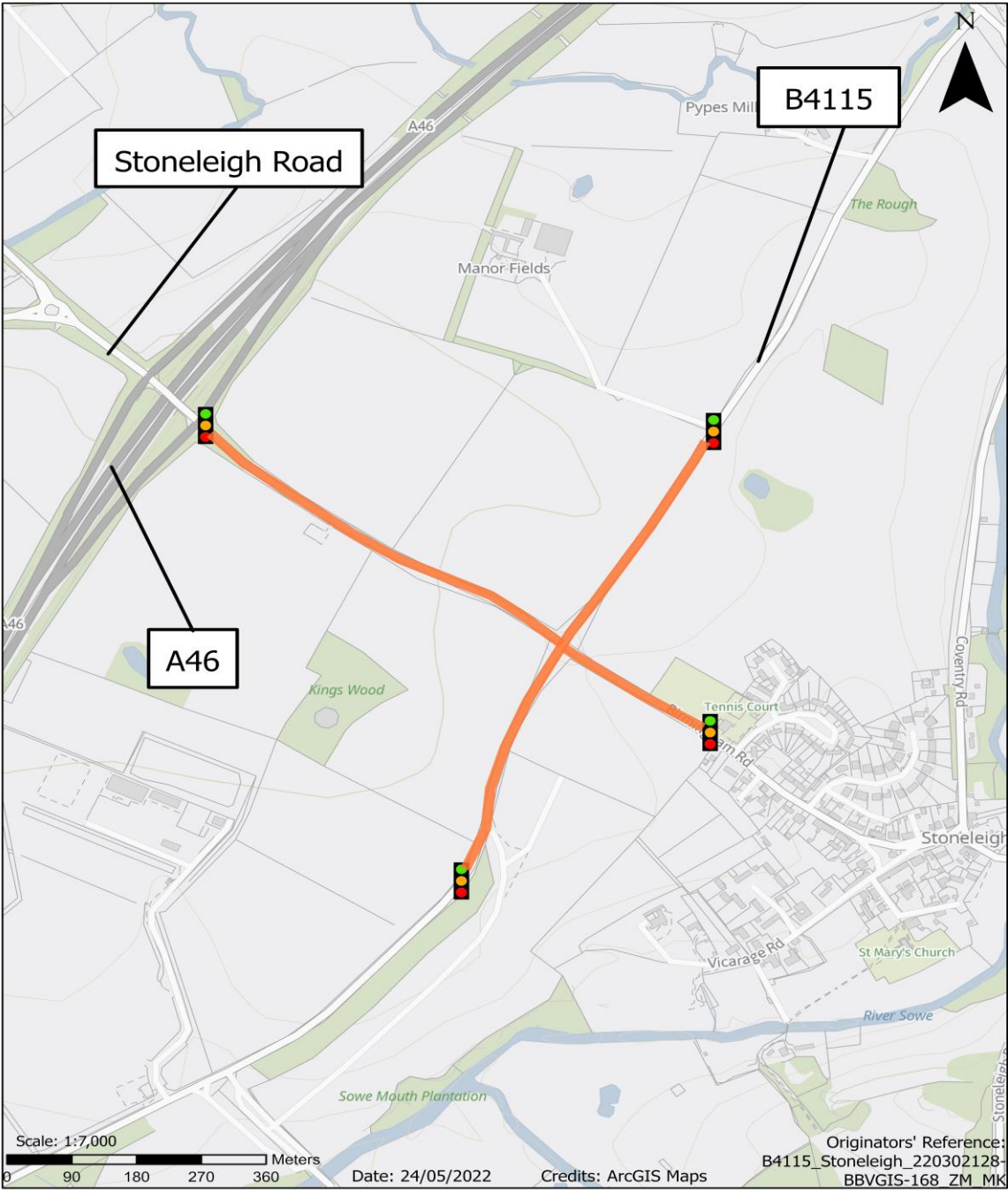
