High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

In order for us to undertake drainage surveys, we will be closing Crackley Lane, Kenilworth from **Monday 23 May 2022** to **Friday 27 May 2022**. The closure will be in place between **9.30am and 3.30pm**.

- A fully signed diversion will be in place during this closure. (Please see map below).
- Please note that access will be maintained to all properties during these works.

HS2 during the Coronavirus pandemic

What to expect

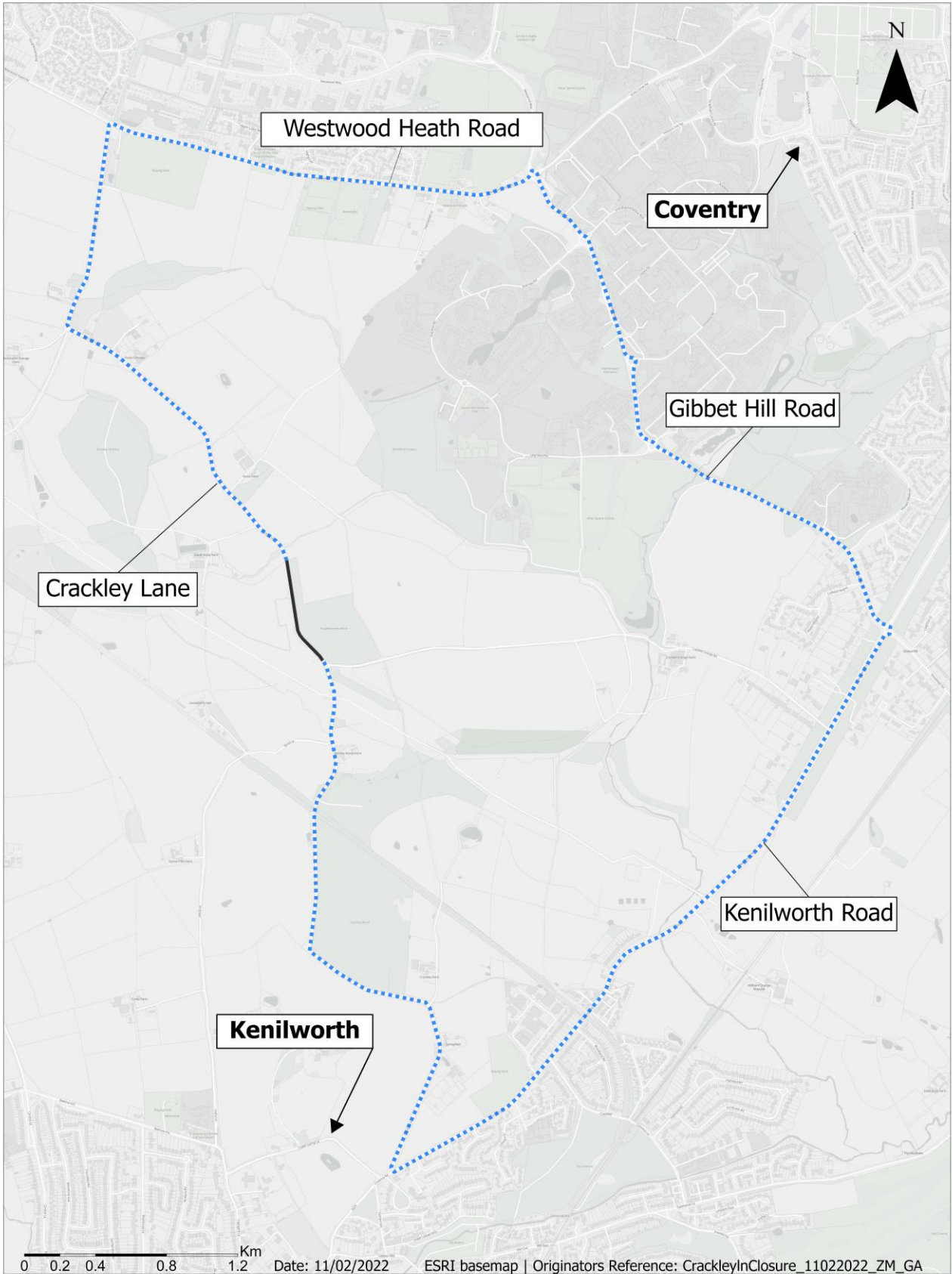
A fully signed diversion will be in place.
