



## Notice of road closure Cromwell Lane, Burton Green

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

In order to undertake gas and sewer diversion works, we will be closing Cromwell Lane between Red Lane and Hodgetts Lane.

### When these works will take place

These works will be taking place in three phases between Tuesday 14 June 2022 and Wednesday 24 August 2022.

**Phase one:** Will be an off-peak closure from 9.30am to 3pm from Tuesday 14 June to Friday 17 June. **Complete.**

**Phase two:** Will be a full closure 24 hours a day 7 days a week from Monday 20 June to Friday 1 July. **Complete.**

**Phase three:** This phase was originally programmed between Monday 25 July and Saturday 20 August, however due to circumstances beyond our control this will now be a **full closure 24 hours a day seven days a week** from **Monday 1 August to Wednesday 24 August**. We apologise for any additional inconvenience this delay may cause.

Our working hours will be 8am to 6pm on weekdays and 8am to 1pm on Saturdays.

Pedestrian access on Cromwell Lane will be maintained at all times.

A fully signposted diversion will be in place throughout the closures and access to all properties will be maintained.

Our workforce may be on site one hour before and one hour after to set up and secure our equipment.

### Duration of works

Cromwell Lane will be closed in three phases:

**Phase one:** 9.30am to 3pm between 14 June and 17 June.

**Phase two:** 24 hours a day between 20 June and 1 July.

**Phase Three:** 24 hours a day now between **1 August** and **24 August**.

Our working hours will be 8am to 6pm on weekdays and 8am to 1pm on Saturdays.

Our workforce may be on-site one hour before and one hour after to set up and secure our equipment.

Some limited disruption to travel times.

A fully signposted diversion will be in place.
