



# UPDATE: Six-month extension of Stamford Brook Sewer works on Wormwood Scrubs

High Speed Two (HS2) is the new high speed railway for Britain.

As we reintroduce face to face engagement, which is in addition to the ongoing virtual engagement, we will continue to follow government guidance on reducing the spread of Covid-19. The health and safety of our workforce and the communities we work within is our priority. ## Extension of duration of works

Due to design changes that have taken place in the Old Oak Common station site, the length of time the sewer diversion work needs to be carried out within the Stamford Brook Sewer (SBS) site on Wormwood Scrubs will have to be extended for a further six months.

The SBS diversion was due to be completed in August 2022, however the work is now expected to continue for a further six months until late February 2023, which means the site access route from Old Oak Common Lane to the SBS site will now be in use for an additional six months. We have worked with London Borough of Hammersmith and Fulham (LBHF) and the Old Oak & Park Royal Development Corporation (OPDC) to extend the temporary planning permission for the access route from 18 months to 24 months.

After this work has been completed the SBS site, and the access road leading to it, will be reinstated, and handed back to LBHF.

The Undertrack Crossing (UTX) site in the north-west corner of Wormwood Scrubs will remain in place while we divert the utilities in this area. Vehicles will continue to access this site via Old Oak Common Lane while the utility diversion work continues.

## Duration of works

Extension of works in the Stamford Brook Sewer (SBS) site on Wormwood Scrubs and use of the alternative access route from Old Oak Common Lane to the SBS site until February 2023.

## What to expect

Site works in the SBS site for a further six months.

Vehicles accessing site during this time.

## What we will do

We will use best practicable means to minimise any traffic by staggering the delivery times, so only one vehicle is accessing site at any one time.

We will also be monitoring noise levels.

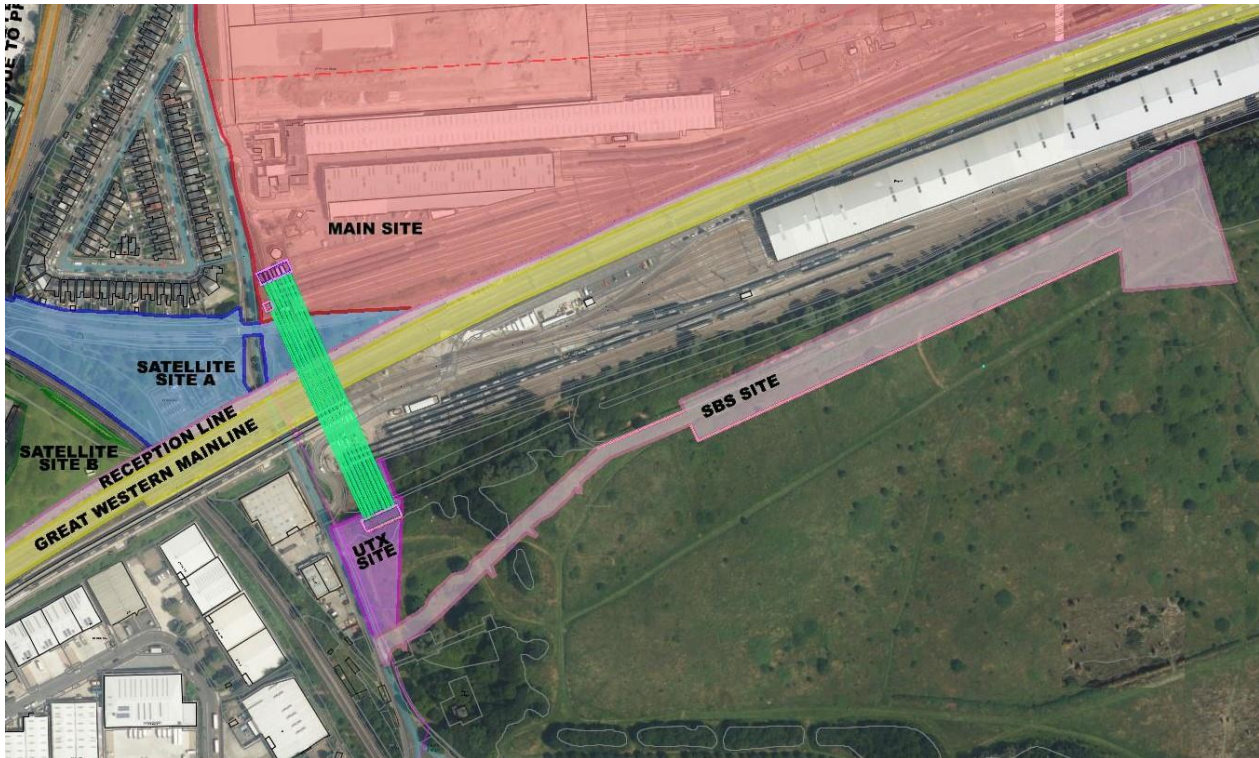
