



## Notice of traffic management on Gilson Road (revised date)

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### The work we will be completing

Originally BBV were set to complete vegetation clearance works under traffic management from Monday 19 April in areas of Gilson Road. Due to unforeseen circumstances, the works were postponed in this location. However, we will now complete the vegetation clearance works from Monday 16 May. The works will be completed in preparation for the construction of the railway. All necessary permits will be in place prior to works being complete and where necessary, ecological surveys will be conducted prior to and during the works.

In order for us to carry out works close to Gilson Road safely, we will install a temporary two-way traffic light system here from Monday 16 May until Saturday 28 May. **(The location of this traffic management is shown below.)** Our working hours will be 9.30am until 3.30pm Monday to Friday and 9.30am until 1.00pm on Saturday.

### COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

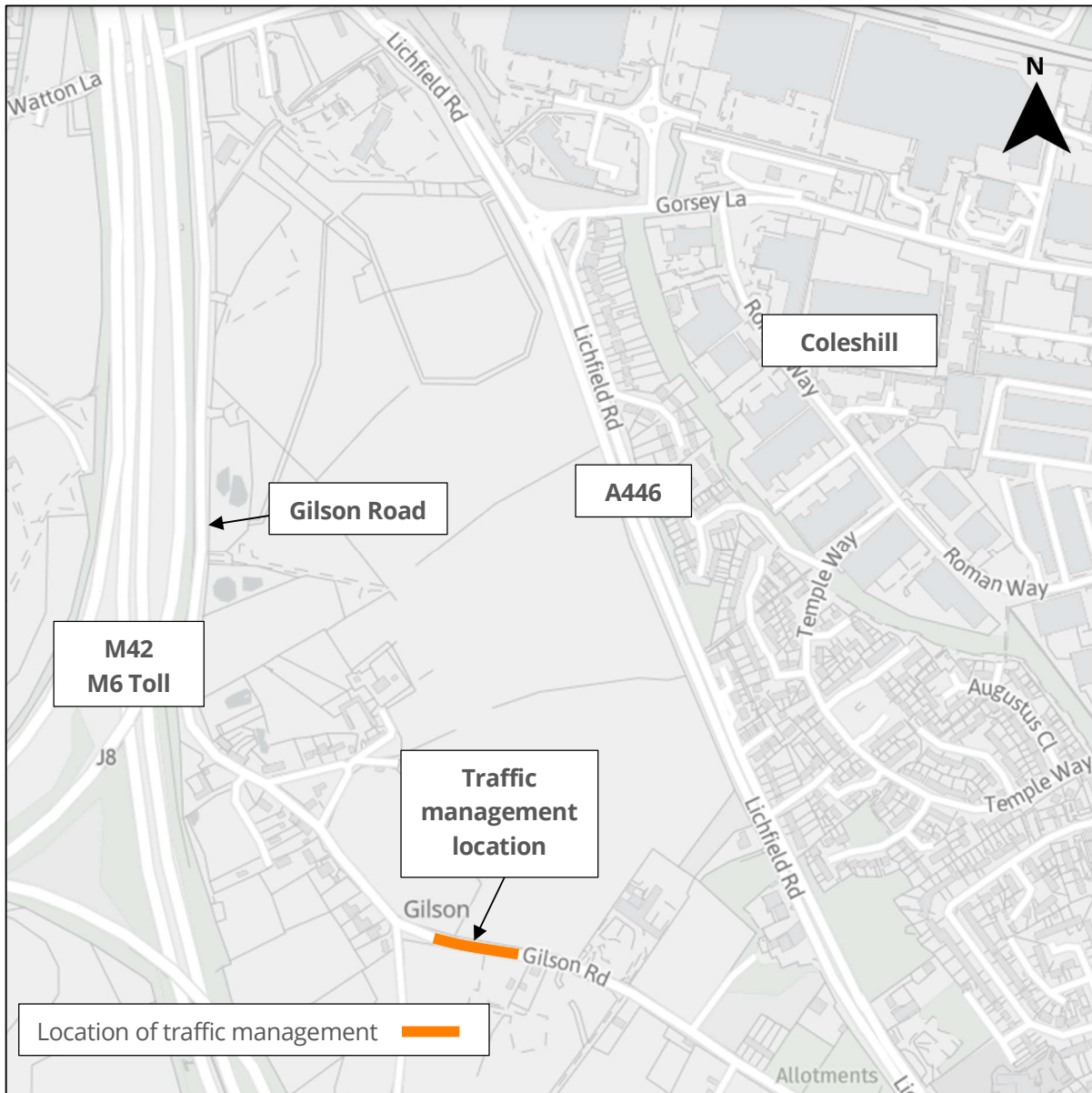
