High Speed Two (HS2) is the new high speed railway for Britain.

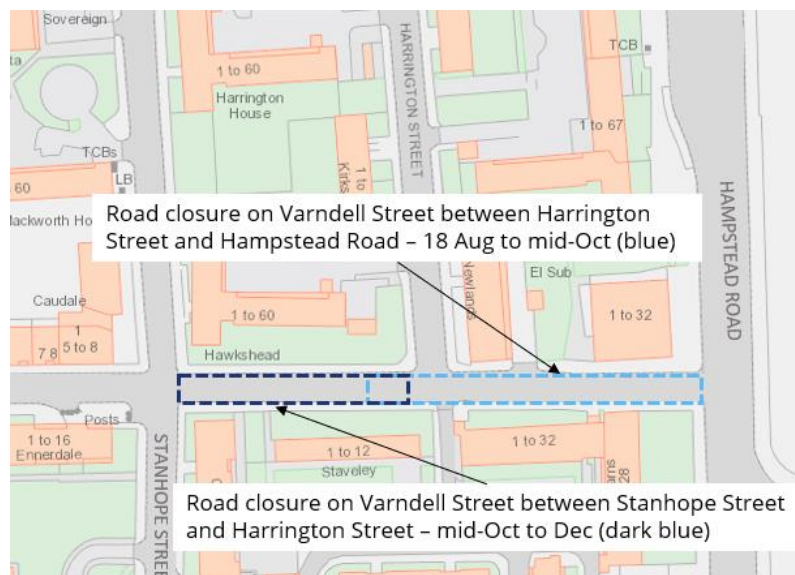
## Road closed on Varndell Street ongoing until December

We are installing a new cable route from Lidlington Place to Varndell Street.

Due to a number of underground obstructions, our works on Varndell Street are taking longer than we expected. The current traffic management on Varndell Street will now remain in place until mid-October.

Once we finish this section, we will move onto the next section of Varndell Street between Harrington Street and Stanhope Street. At this point, we will reopen Varndell Street between Hampstead Road and Harrington Street, allowing vehicles to access the eastern end of Varndell Street and Harrington Street as normal.

We expect to finish our works on Varndell Street in December. We are sorry for the disruption and thank you for your ongoing patience.
