AMENDMENT TO PREVIOUS NOTICE (See details for 1 July 2022)

High Speed Two (HS2) is the high-speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

In order to construct and complete site access in the area, we will be closing Leicester Lane. Following this, we will be undertaking works on the verges of the road, with temporary traffic lights used overnight and when closures are lifted. **A fully signed diversion will be in place during closures** (please see map overleaf). **Access to all properties will be maintained throughout these works.**

When these works will take place

- From **Monday 6 June to Friday 17 June 2022**, we will be closing Leicester Lane between 8am and 6pm Monday to Friday with temporary traffic lights in place outside of these hours. There will be no traffic management during the weekend of the **11 and 12 June 2022**.
- From **Monday 20 June to Tuesday 28 June**, temporary traffic lights will be in place 24 hours a day seven days a week.
- On **Wednesday 29 June**, a **full closure** of Leicester Lane will be in place between the hours of 8am and 6pm.
- On **Thursday 30 June**, temporary traffic lights will be in place, followed by a full closure on
- **On Friday 1 July, a full closure of Leicester Lane will be in place between the hours of 8am – 6pm.**
- From **6pm on 1 July until 6pm on Friday 8 July**, temporary traffic lights will be in place, 24 hours a day.

Duration of works

- Our works are scheduled from 6 June 2022 to 8 July 2022.
- Road closures will be in place 8am-6pm.
- Overnight traffic lights will be in place.
- Our working hours will be 8am to 6pm.
- Our workforce may be on site one hour before and one hour after to set up and secure our equipment.
- No weekend work will take place

What to expect

- Some disruption to travel times.
- A fully signed diversion will be in place.
- Access to all properties will be maintained during this closure.
- Some noise from onsite machinery during working hours.

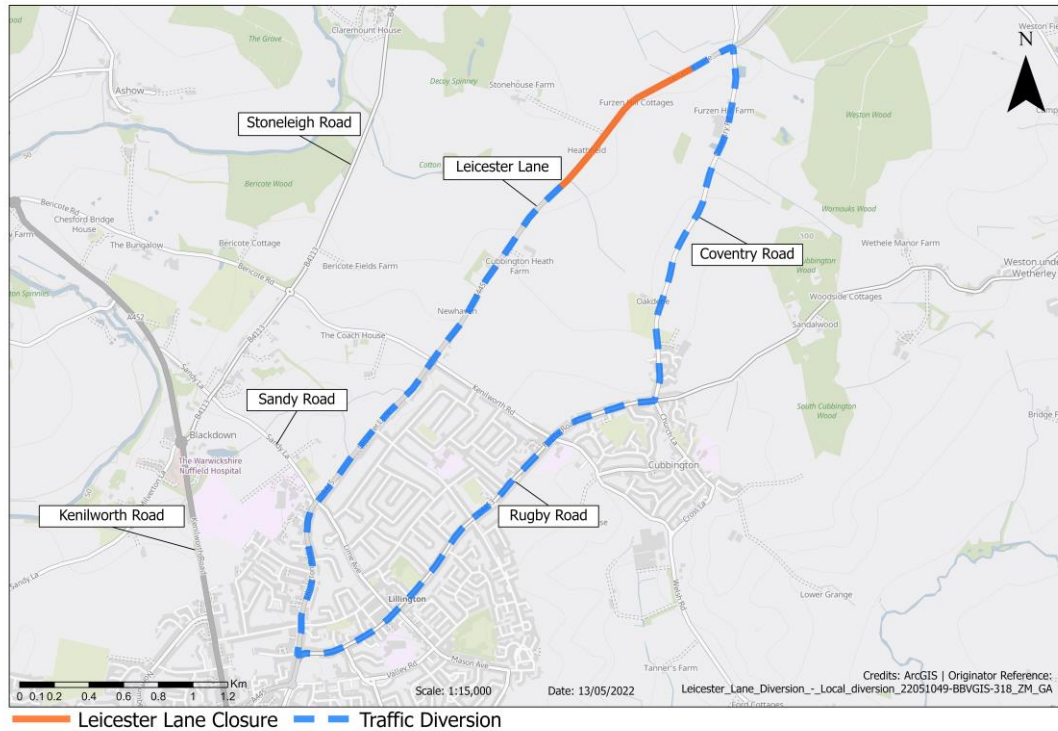

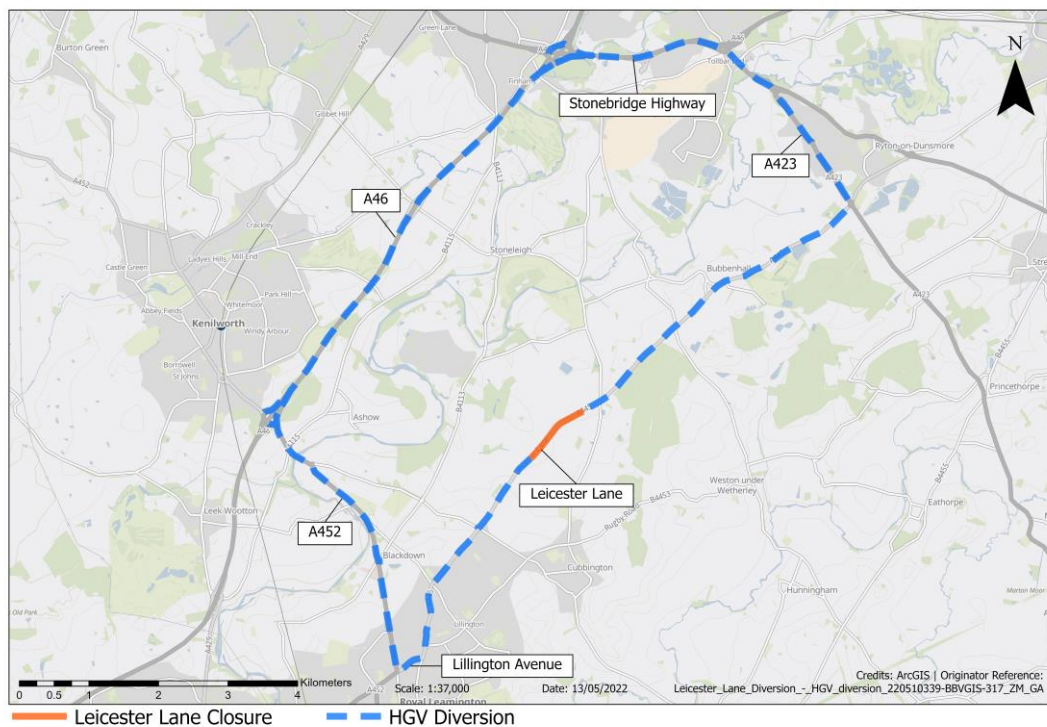
