# **Upcoming Ground Investigation works Castle Bromwich, Birmingham**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci is working on behalf of HS2 Ltd to build the new railway in your area.

# When, where and why the need for Ground **Investigation works**

We intend on carrying out ground investigation works within sections of Castle Bromwich Business Park as well as along sections, as shown overleaf, of Tameside Drive and Cadbury Drive.

We plan to undertake these works between Monday 9 May 2022 and Monday 30 May 2022, excluding weekends. Temporary 'Stop & Go' traffic lights will be in operation daily from 8:00am until 5:00pm weekdays only.

These works will enable us to locate third party utilities and their proximity to the new railway track.

Pedestrian access will be maintained.

# **HS2** during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.

Continue to keep public safety and that of our workforce as top priority.


