High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out Early Environmental Works between Lichfield and Crewe.

What we are doing

We will be creating ecological mitigation ponds surrounded by grassland habitat creation on land off Tolldish Lane, Great Haywood. We will use the ponds to relocate any protected species, such as Great Crested Newts before we need to remove any other habitats. Later in the year, we will create wildflower meadows and start woodland planting.

Before the work starts and to set up the site, we will install track matting to allow machinery to get on. As part of the work, we will also create hibernaculums and install bat and bird boxes. Hibernaculums are places where creatures such as reptiles seek refuge to keep themselves warm over the winter period.

When the work take place?

We will start site set up on 30 May 2022. Following this, we will begin work to create the ponds themselves and this will be ongoing throughout the year.

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
