Notice of road closure, Shipton Lee Road, Quainton

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. What are we doing?

In the middle of June, we will begin construction on the crossing point for our site access road across Shipton Lee Road, also known as Lawn Hill.

We will create a crossing area where our internal haul and access roads will cross the highway. In order to protect the road and any utilities underneath, we first need to create a strengthened surface at the crossing area using concrete. As the project progresses, it is also necessary to remove vegetation to enable future works to continue and to allow access to areas of the site.

Once our crossing areas are fully installed, they will provide safety to both local road users and our construction staff by installing traffic signals and in some locations, barriers, to manage the flow of construction traffic crossing the highway.

These preparatory works will require large plant and machinery, as well as the setting of concrete, so we will need to fully close this section of Shipton Lee Road 24-hours a day until the work is complete.

When will these works take place?

A section of Shipton Lee Road will be fully closed, 24 hours a day from Wednesday 15 June to Saturday 16 July 2022, including weekends. There will be a signed diversion route in place.

We will work to reopen the road as soon as possible.

Duration of works

Works will take place from Wednesday 15 June 2022 to Saturday 16 July 2022.

24-hour full road closure including weekends.

What to expect

24-hour full road closures due to excavations of the road and to allow concrete to set.

Some additional traffic.

Noise from plant and equipment used for the works.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.

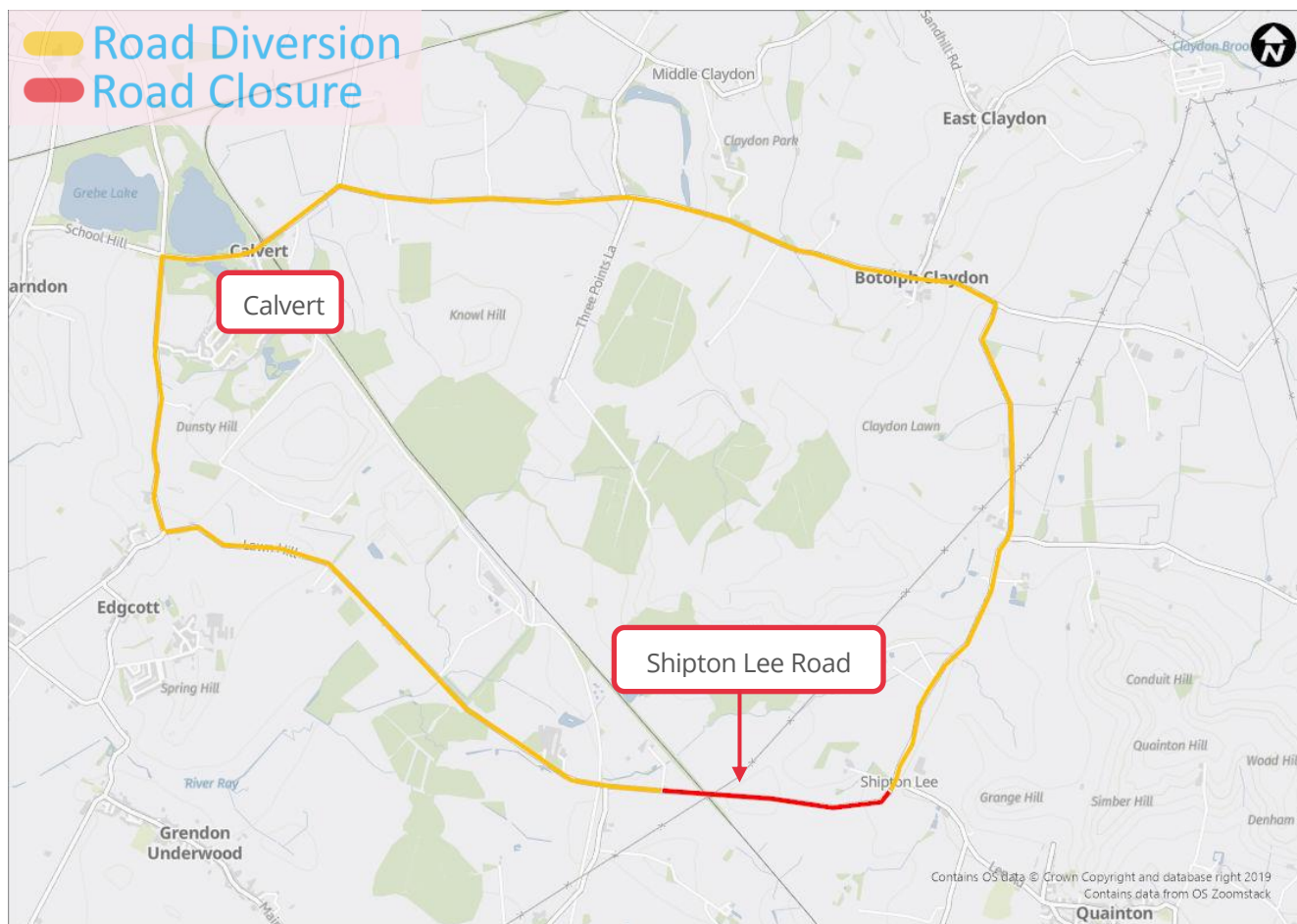
