High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out Early Environmental Works between Lichfield and Crewe.

What we are doing

We need to cut back some branches that are overhanging onto Yarnfield Lane to maintain the safety of road users and the public. To do this safely, we need to install temporary traffic lights either side of our works entrance, along Yarnfield Lane.

When the work will take place

We will put temporary traffic lights on Yarnfield Lane from Thursday 26 May to Tuesday 31 May, 9am to 3.30pm. We will carry out the work during these hours.

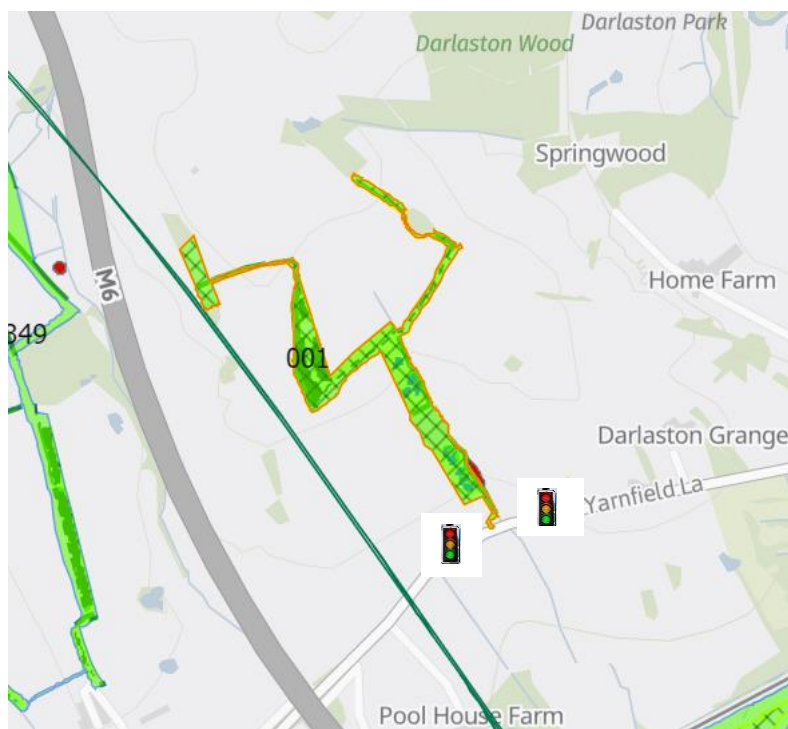

To cut the branches, we will be using chain saws which may generate some noise, but we will be working during the day to minimise disruption to local residents. You may notice some queuing on the road while the lights are in place. The map below shows where we will be working. About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
