

# Notice of temporary closure of Lavender Hall Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

Due to the future realignment of Lavender Hall Lane, it will be necessary for us to install a temporary gas pipe under the road. For us to carry out this work safely, we need to put in place a temporary closure of Lavender Hall Lane. For safety reasons and at the request of SMBC it will also be necessary for us to close Baulk Lane, this is due to Baulk Lane not being suitable for 2-way traffic. **A fully signed diversion will be in place. (Please see map overleaf).**

The Baulk Lane closure is for motor vehicles only and will remain open for pedestrians, cyclists, and horse riders.

Access to all properties will be maintained at all times.

## When will this work take place?

The closures will be in place from Monday the 27 June 2022 until Friday 22 July 2022 24 hours a day including weekends.

Our working hours will be Monday to Friday 8am to 6pm and Saturday 8am to 1pm. Our workforce may be in place one hour before and one hour after to set up and secure our equipment.

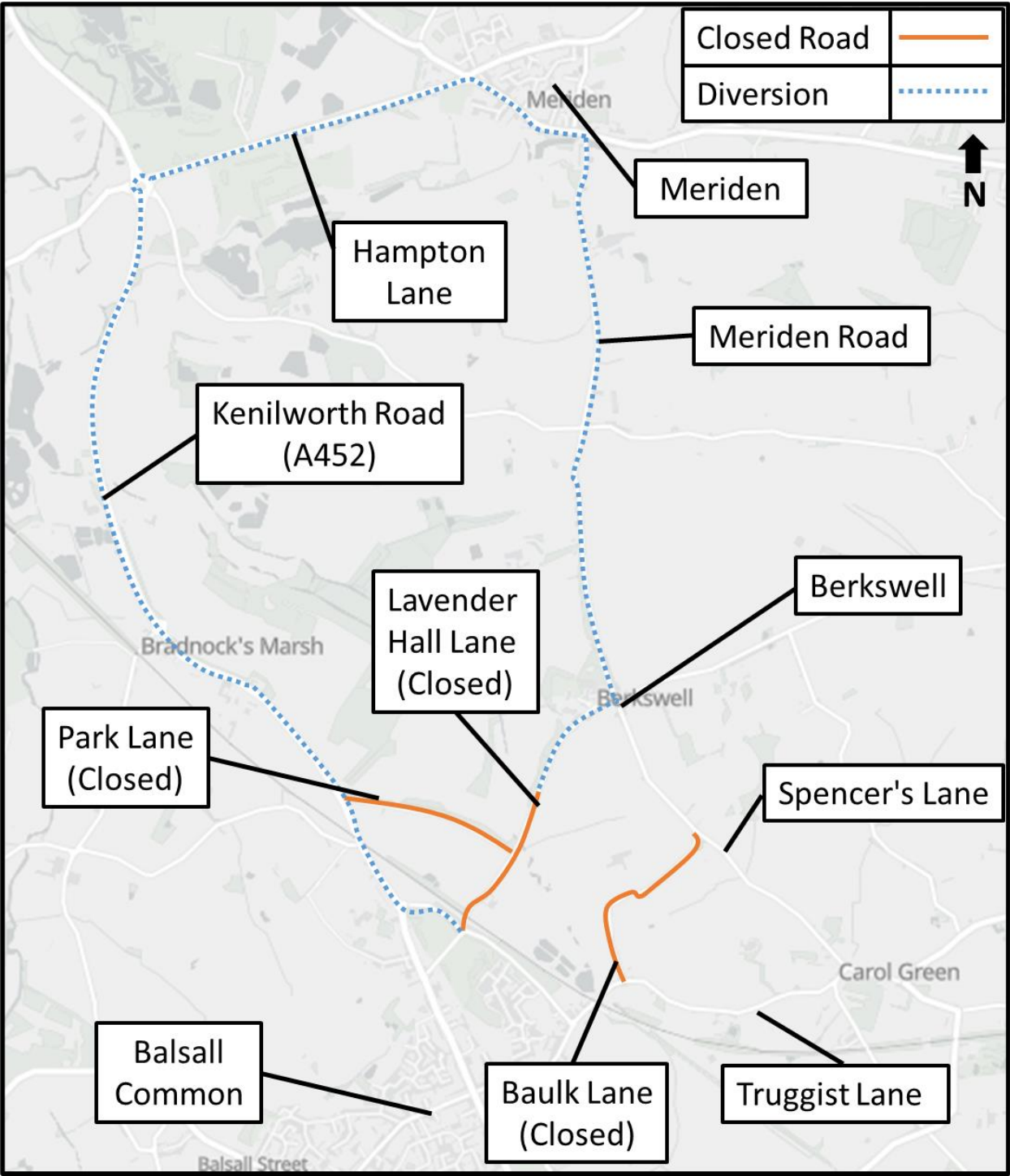
