High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be completing works on the B4114 to widen the existing access on the south verge of the B4114 and to create a new access on the north verge of the B4114. **(Location of this work is shown on the map on page 2).** For us to complete these works safely, we will implement a three-way traffic light system on the B4114 Birmingham Road. The traffic lights will be in place 24 hours a day from Monday 6 June until Saturday 18 June 2022. The traffic lights will be manually controlled at peak hours.

Our working hours will be 8.00am until 6.00pm Monday until Friday and 8.00am until 1.00pm on Saturdays. Our workforce may be on site one hour before and after to set up and take down equipment.

HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

- Widening of existing access and creation of new access on the B4114
- Works to be undertaken from 6 June until 18 June

What to expect

- Three-way traffic light system in place on the B4114 Birmingham Road
- Our working hours will be from 8.00am until 6.00pm Monday – Friday and 8.00am until 1.00pm Saturdays
- Our workforce may be on site one hour before and after to set up and take down equipment

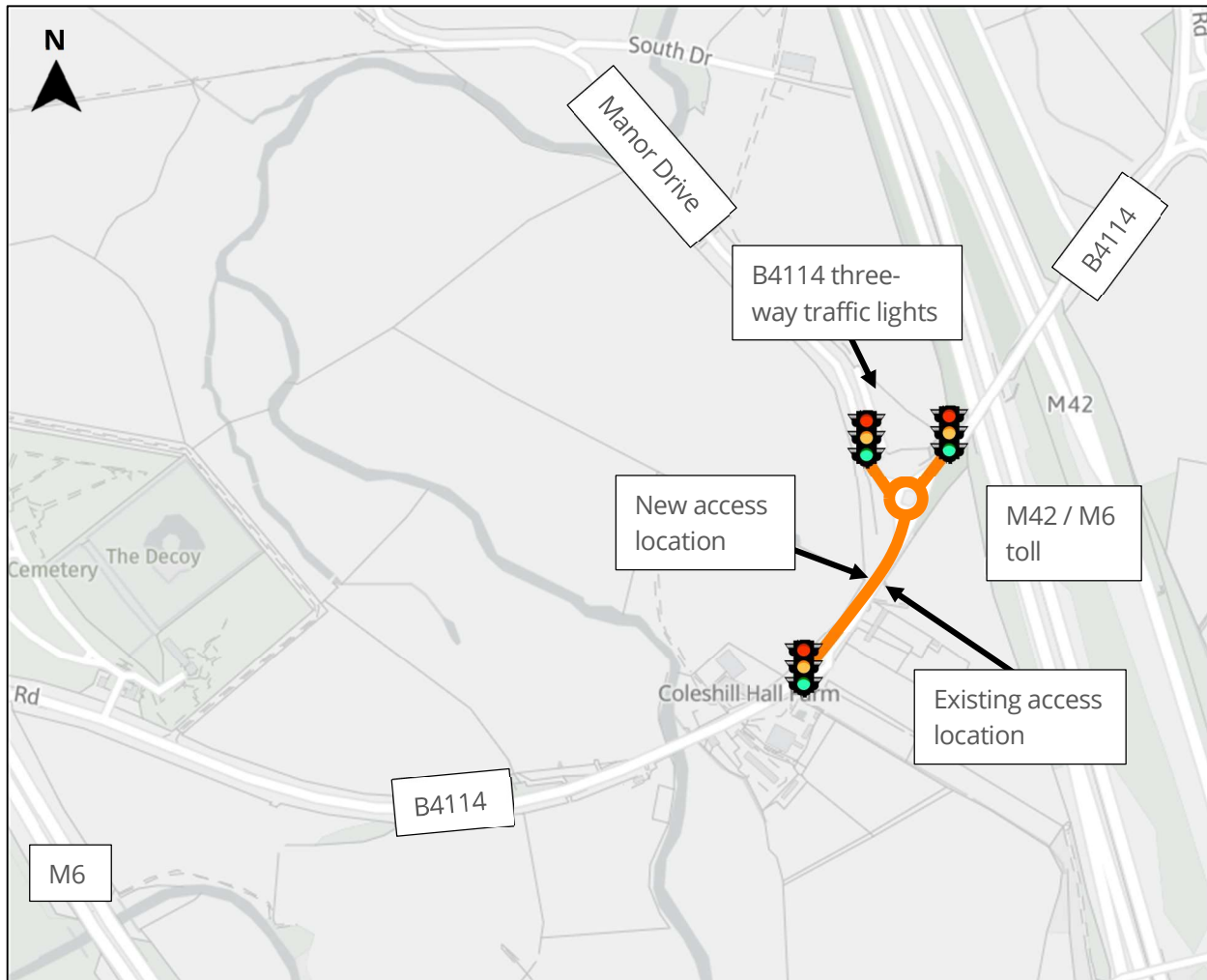
