High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

To inform our design of the future HS2 railway, we need to carry out surveys in the area. We will complete surveys on areas of Gilson Road for one day on Monday 30 May.

In order for us to carry out works close to Gilson Road safely, we will install a temporary two-way traffic light system here on Monday 30 May. **(The location of this traffic management is shown below.)** Our working hours will be 9.30am until 3.30pm.

COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. 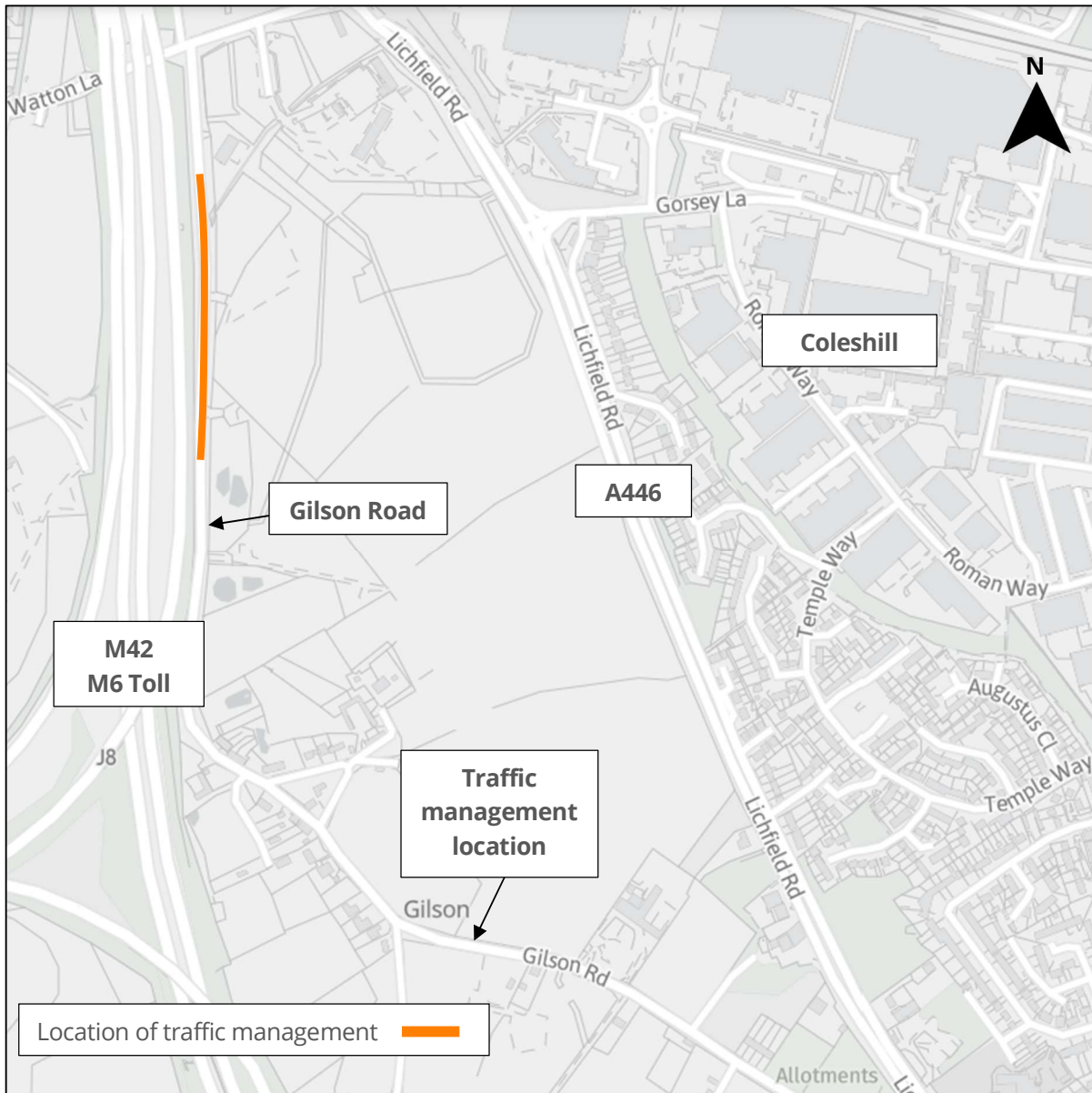
