High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Postponed closure of Saltley Viaduct

We previously notified you that we would be closing Saltley Viaduct from Summer 2022 until Autumn 2023 as we build a new raised viaduct. We however now plan to postpone construction of the new viaduct until 2024. This means we will not need to close the road until this later date.

We have decided to postpone our works on the viaduct to help keep Birmingham moving, as the city is set to host the Commonwealth Games during the summer. The games will take place between 28 July and 8 August and are expected to attract over one million visitors to Birmingham, putting added pressure onto the road networks.

We will share more details about the planned closure of Saltley Viaduct closer to the time.
