



# Notice of Public Right of Way diversion, Whittington

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing

As part of our enabling works to prepare for the construction of the HS2 line, we will be undertaking utility diversions within the area. To enable these utility diversions to take place, we will be undertaking vegetation clearance around Public Right of Way Whittington 16. In order to ensure the safety of the public and our workforce we will be diverting Whittington 16, along Whittington 17 Public Right of Way.

## When the work will take place

We will be diverting the Public Right of Way from Thursday 19 May for a duration of five weeks. Our working hours will be between 8am and 6pm. We may be on site up to an hour before and after to set up and secure our equipment.

## Where we will be working

We have detailed the Public Right of Way closure and diversion on the map below which will be in place for five weeks from Thursday 19 May.
