

Notice of survey work on Yarnfield Lane and the A34

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Kier is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

We will be carrying out ground penetrating surveys to help us identify the location of buried utility services, such as gas, electric or water. These surveys are non-intrusive, we will use a machine that transmits an electromagnetic pulse into the ground. These pulses reflect off features in the ground, allowing us to collect data and to understand the depth of the buried utility services.

Along with ground penetrating surveys, we will carry out several other surveys. For the safety of both our workforce and motorists, we need to close Yarnfield Lane overnight from Moss Lane to the A34 junction. We will also need to close lane one of the carriageways on the A34 northbound between Walton roundabout and the Fillybrooks roundabout.

When the work will take place

Earlier this year, we partially completed ground penetrating surveys at this location using temporary traffic lights. However, to complete these surveys between Moss Lane and Yarnfield Lane/A34 junction safely, we need to close the road. To minimise disruption to the community, we will close the road overnight from **Monday 6 June** to **Friday 17 June 2022**. Please note that all our planned roadwork may be subject to change due to weather conditions or unforeseen circumstances.

Covid-19

We are working in line with Government and Public Health England (PHE) advice on working safely during the pandemic. For all events and engagement, we will carry out a risk assessment and put in place control measures to manage the risk of Covid-19 to the public and our staff. How this will affect your journey


On **Monday 6 June** to **Friday 17 June** from **10pm** to **5am** we need to close Yarnfield Lane from Moss Lane to the junction of the A34. During the closures, we will put a signed diversion route in place. We will also have advance warning signs on display to notify motorists of the upcoming work. Please allow an additional 15 minutes for your journey.

During this time, we also need to close lane one of the A34 from the Walton roundabout to the Fillybrooks roundabout to allow for surveys to be undertaken.

How we will minimise disruption

To minimise disruption, we will be undertaking the work overnight. We will maintain access to all properties within the traffic management set up using the interactive communication boards. The nature of the work is non-intrusive and should not affect nearby properties.

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
