



Works to start excavating Westgate ventilation shaft

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can work within the guidelines are operational. All sites will remain under constant review.

Works to build a ventilation shaft from July 2021

From late July 2021, we will start works to build the ventilation shaft at our Westgate site. This will be 15 metres wide and about 43 metres deep to connect to the HS2 tunnels. We will start constructing the tunnels in this area from 2023.

Our construction team will build the ventilation shaft in stages:

1. We will install a concrete collar around the top of the shaft to support the ground.
2. We will install concrete rings and excavate the ground in layers to build the shaft.
3. When the ventilation shaft reaches about 11 metres below ground, we will continue excavation in layers and apply sprayed concrete lining (SCL) until the shaft reaches its depth of about 43 metres.

Our working hours

During July and most of August, we will be working from 8am to 6pm on Mondays to Fridays and 8am to 1pm on Saturdays. From late August, we will extend our working hours to 24 hours a day on Mondays to Fridays. We will continue to work on Saturdays from 8am to 1pm.

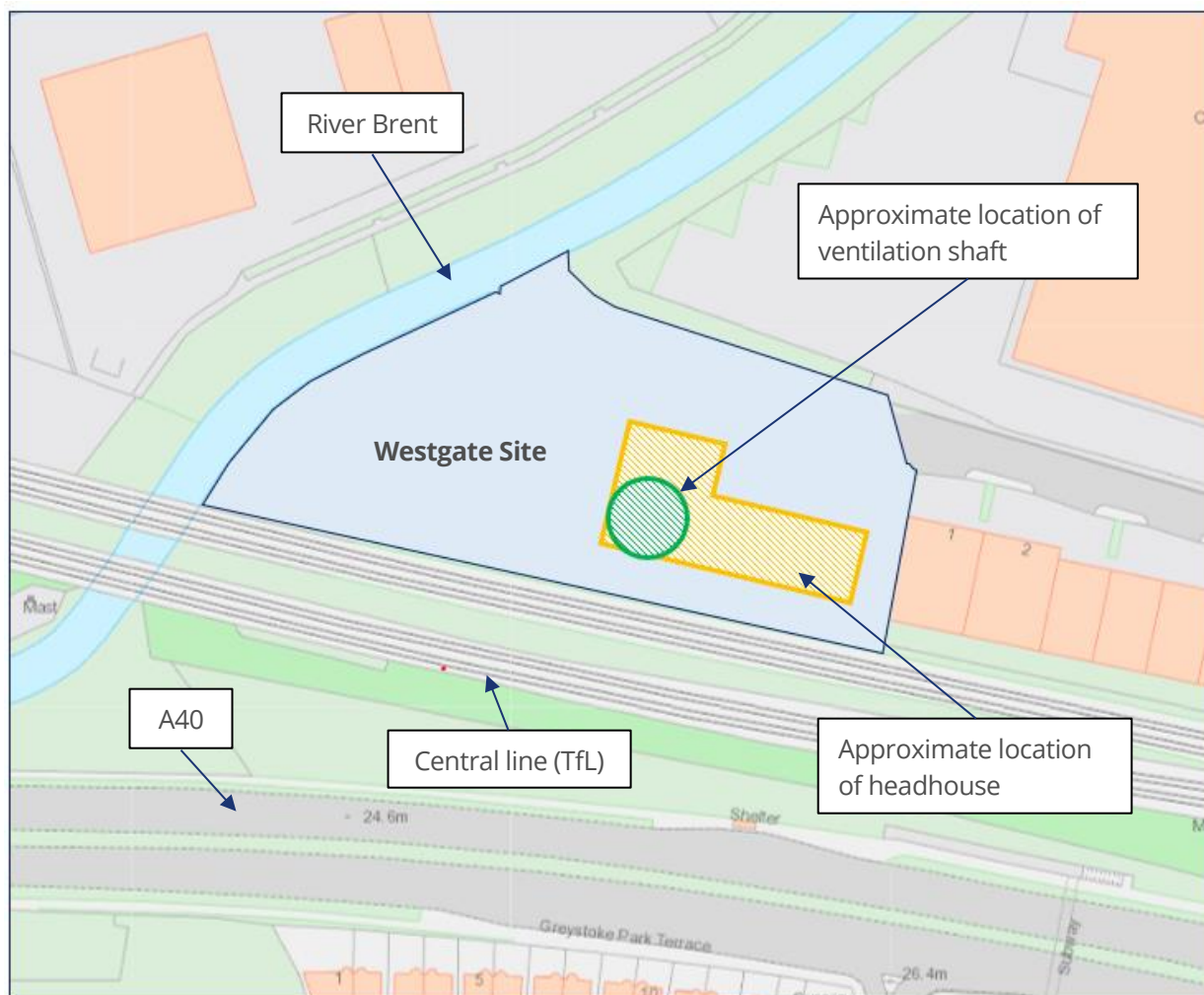
