High Speed Two (HS2) is the new high speed railway for Britain.

As we reintroduce face to face engagement, which is in addition to the ongoing virtual engagement, we will continue to follow government guidance on reducing the spread of Covid-19. The health and safety of our workforce and the communities we work within is our priority. Upcoming works on Adelaide Road and Eton Road

From 11 July to 22 July 2022 National Grid will carry out works to protect cables underneath Adelaide Road. The works will take place within the HS2 site, and within the current lane closure. Further information about these works can be found on page 3.

From 25 July to 26 August 2022 we will be carrying out works on the main sewer located underneath Adelaide Road and Eton Road.

The purpose of the utility works is to strengthen the existing sewer pipe by installing a sewer liner which will protect the main sewer while we build HS2 tunnels in the London Borough of Camden. We will do this by digging into the ground to create a trench which will be at the depth of the main sewer pipe underneath Adelaide Road. Once complete, we will carry out the installation of a liner inside the sewer.

How might this affect you?

We will have a road closure in place at the junction of Eton Road and Adelaide Road between 25 July and 19 August 2022.

From 22 to 26 August 2022, Adelaide Road will reopen but the road closure will remain in place on Eton Road. You can view maps showing the location of these works on the following pages.

Clearly signed traffic, cycle and pedestrian diversion routes will be in place for the duration of these works.

Your utility services will not be affected during these works and we will use noise reducing barriers where possible.

Duration of works

Works will start from 11 July 2022, between 8am to 6pm, Monday to Friday, and 8am to 1pm Saturdays if required

We may be on site for an hour before the start and/or end of each shift

Road closure at the junction of Adelaide Road and Eton Road, from 25 July to 19 August 2022

Eton Road only, from 22 to 26 August 2022

What to expect

Clearly signed diversion route will be in place for vehicles, pedestrians, and cyclists

Increase in construction vehicles on Adelaide Road and Eton Road

What we will do

Noise reducing barriers will be in place during these works, where possible

We will continue to monitor noise, dust, and vibration levels

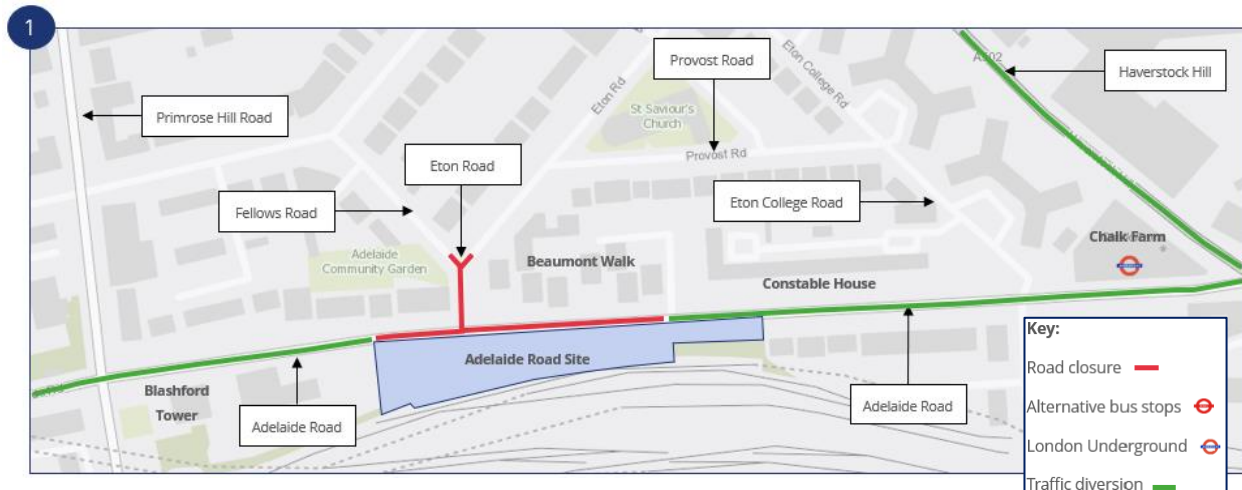

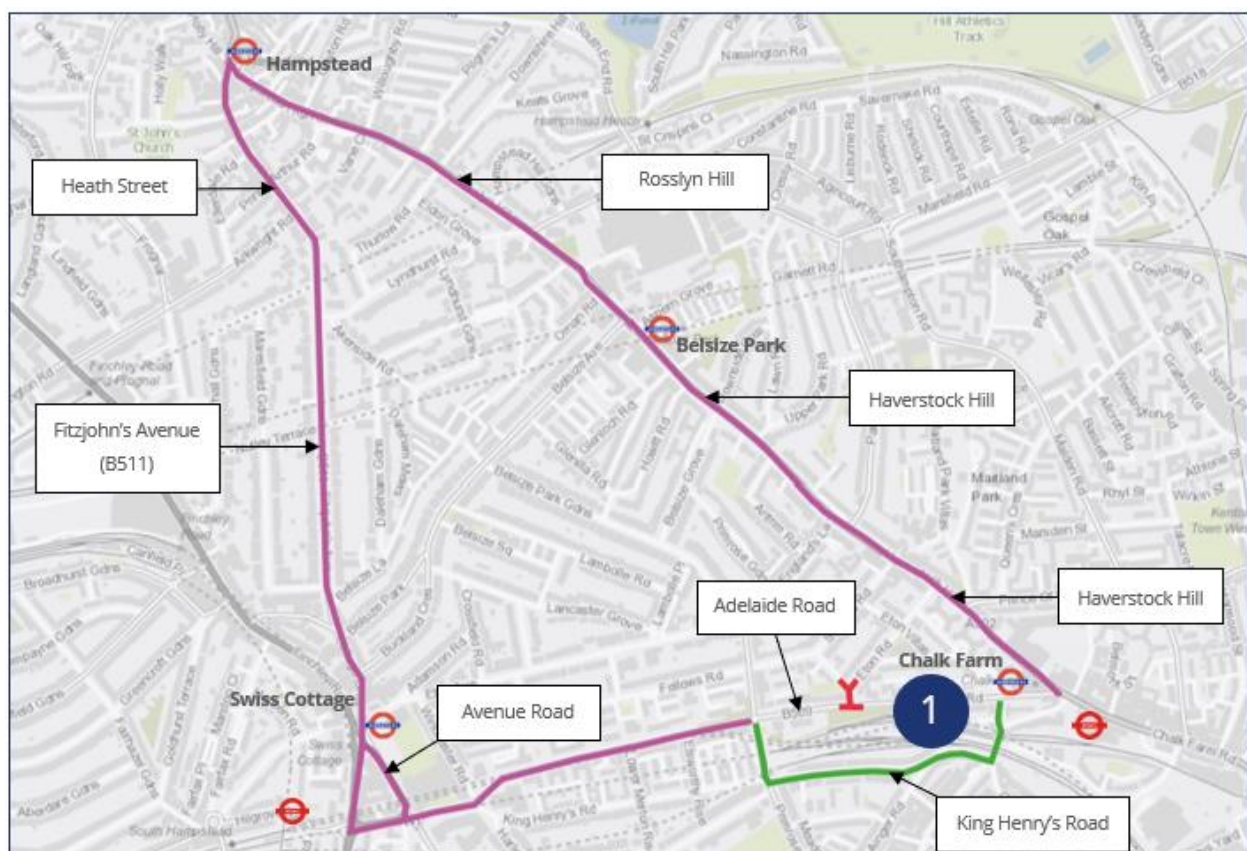

How can I travel through the area?

Travelling by bus

Eton Road (Stop R), Chalk Farm (Stop CB) and Chalk Farm (Stop CA) will be closed for the duration of our works. The nearest bus stops for bus routes 31, N28 and N31 are Finchley Road South Hampstead (Stop K) and The Roundhouse (Stop CF).

Travelling by car

To help us maintain traffic flow on the road network, we have agreed a diversion route with Camden Council and Transport for London.

Please look at the map on page 2 for the full diversion route.

Travelling by bicycle

Cyclists will be diverted towards King Henry's Road. We have agreed this diversion route with Camden Council.

Travelling by foot

Pedestrians will be diverted up Eton Road and will be able to walk around the road closure. A clearly signed diversion route will be available.

National Grid works

Between 11 July and 22 July, National Grid will carry out works to protect cables underneath Adelaide Road. The initial works will take place within the SCSJV Adelaide Road Vent Shaft construction site on Adelaide Road. This will be followed by additional works being completed 20m west of this site between 25 July to 19 August 2022. The additional work will be located on either side of the road and the pavement outside Adelaide Medical Centre.

Ground anchors update

The start date for the installation of ground anchors at Adelaide Road has changed since we last notified you. The works will now start in August 2022, for up to 19 weeks. We will provide updates at hs2.org.uk/in-your-area/.

Further utility works will take place on Adelaide Road from 29 August until late October. Lane closures will be required. Further information will be provided nearer the time. We will provide updates at hs2.org.uk/in-your-area/.
