High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

For the safety of all road users, we will be reducing the speed limit from 70mph to 50mph near the entrances to our work areas on the A446/A452. This is necessary as large vehicles will be travelling slowly in order to enter and exit our work sites

When these works will take place

The 50mph limit will be in place from Monday 27 June 2022 and last approximately 6 months

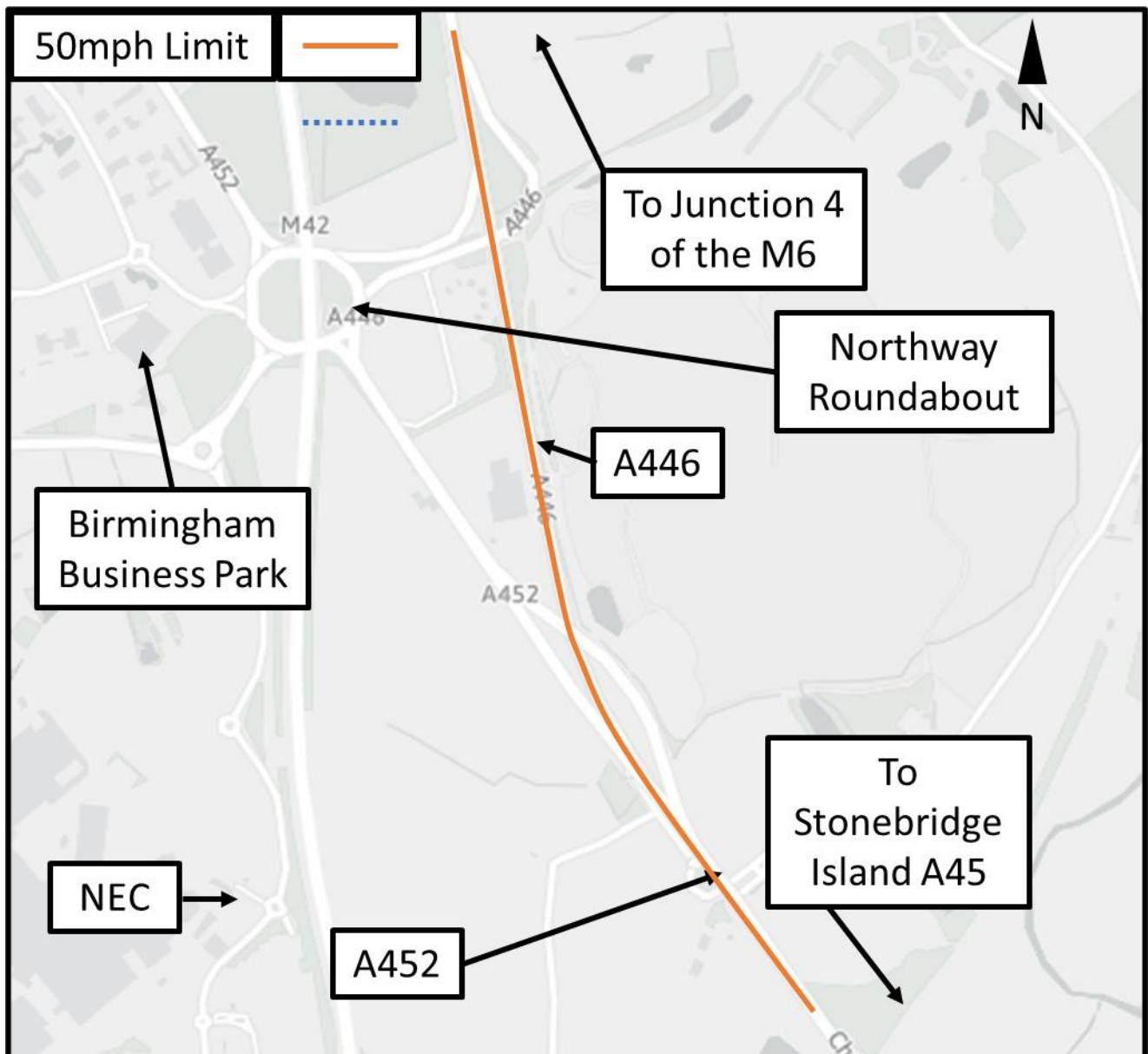
