## Trenchard Avenue temporary borehole works

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we reintroduce face to face engagement, which is in addition to the ongoing virtual engagement, we will continue to follow government guidance on reducing the spread of Covid-19. ### What we are doing

In order to carry out groundwater monitoring, it will be necessary to drill a borehole at the location shown on the map overleaf. In order to carry this out safely, on 23 June we will erect hoarding around a drilling rig. Drilling the borehole should take around five days to complete. The borehole will then have a secure cover.

### How these works might affect you

Some noisy drilling whilst we create the borehole.

The borehole will be in use for approximately five years so we can carry out groundwater monitoring. There will be routine visits to carry out the monitoring using handheld equipment. This should take no more than twenty minutes each time.

We would like to apologise in advance for the disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.


