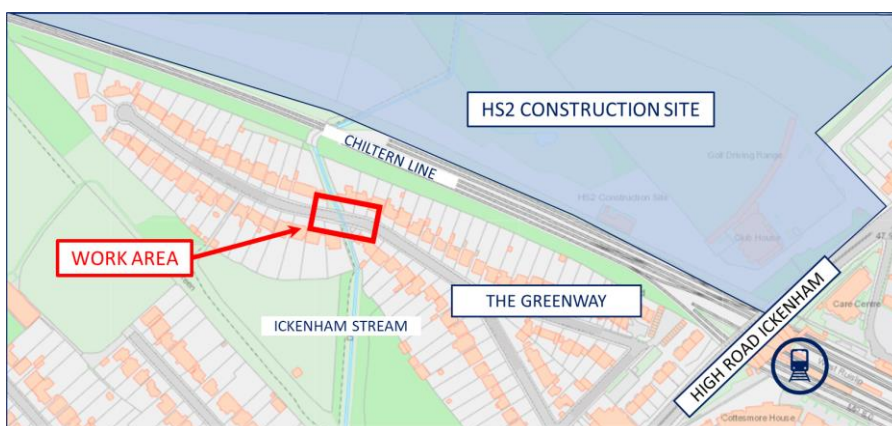
What we are doing

From 29 to 30 June 2022, we will undertake ground penetration radar surveys to scan and identify utilities along the Greenway at the Ickenham stream bridge area. For safety reasons and to facilitate these works, we will need temporary traffic management to be in place. Access for residents will be maintained.

This activity should be completed in one day if the weather permits.
