High Speed Two (HS2) is the new high speed railway for Britain.

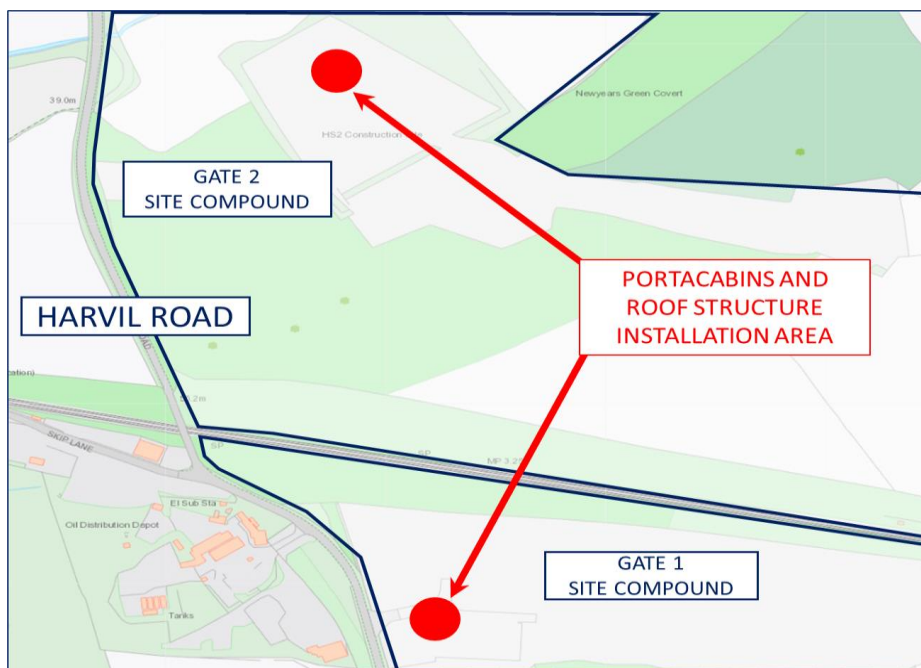

On the weekend of 25 and 26 June 2022, we will be installing portacabins and a roof structure within our site compounds on Harvil Road, as shown on the map below.

We will use a crane to lift the structures into position. These works should not cause any disruption.
