# Notice of traffic management, A423, Southam

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. The health and safety of our workforce and the communities we work within is our priority. All sites will remain under constant review. # What are we doing?

We are building a dedicated exit junction for our main compound on the A423 Banbury Road. This will help reduce our impact on the local road network and provide additional safety for highway users and our staff.

These works will involve our workforce operating in the highway as well as completing road markings and installing signs. For reasons of safety, we will be installing temporary traffic lights for a period of one month.

# When will these works take place?

The A423 Banbury Road will have temporary traffic management 24-hours a day, in the form of traffic lights, from Monday 27 June 2022 for one month.

These dates may be subject to change due to circumstances outside of our control, such as weather.

24-7 traffic lights on the A423 from the end of June.

Access will be maintained for residents and emergency services.


