Location 1 Canterbury	rbury November 2022	Ongoing works at this site include:Network Rail yard enhancement works

Location 1 Canterbury Works site	Winter 2022 to winter 2023	 Ongoing works at this site will include: Construction of a new site entrance on Albert Road including the construction of a new access ramp; Ongoing works to build the ventilation shaft including sprayed concrete lining and waterproofing; Construction of the base slab and reinforced concrete lining in the ventilation shaft; Installation of internal shaft structures (walls, floors and stairs) from early 2023; Works to build the adits (horizontal passages below ground) that will connect the HS2 tunnels; and Installation of a shaft attenuation tank (a storage system for water).

		To carry out these works, extended working hours may be required. We will provide further information to the local community about these works and provide updates about our ongoing works at the <u>in your area</u> <u>map</u> .

Location 1 Westgate site	September to November 2022	 Ongoing works at this site include: Works in the ventilation shaft to complete the adits (horizontal passages below ground that will connect to the HS2 tunnels). These works include excavation and sprayed concrete lining below ground; Construction of the ventilation shaft to the final level including the base slab and tunnel intervention adits; and Utility connections to site.

		Some extended working hours will be required during our ongoing works at the Westgate site. We will provide information to our neighbours in advance of any extended working hours. The latest updates about our ongoing works are available at the <u>in your area map</u> .

The works will include: Ongoing works to build the internal structures in the ventilation shaft including shaft walls, floors, and stairs; Works to build the base slab and piling ahead of construction of the headhouse (the building that will sit on top of the vent shaft); and Works to build the headhouse frame. Some extended working hours will be required during our ongoing works at the Westgate site. We will provide information to our neighbours in advance of any extended working hours. The latest

Various locations, Ealing	Winter 2022 to winter 2023	We will carry out utility and bridge surveys in various locations along the HS2 tunnel route. The surveys will inform future works to protect these utilities and bridges during construction of the tunnels. We may need to carry out some protective works in some local areas in Ealing.


Map 3 – Greenpark Way vent shaft, Greenford

Location 1	September to	Ongoing works at this site include:
Greenpark Way site	November 2022	 Works to build the ventilation shaft, including excavation and installation of concrete rings and sprayed concrete lining;
		 Shaft dewatering (removal of water from ground as the shaft is constructed); and
		• Network Rail track maintenance works every three months.
		Some extended working hours will be required during our ongoing works at the Greenpark Way

Location of works	Proposed duration	Description of works
Location 1 Mandeville Road site	September to November 2022	Works are ongoing to set up the Mandeville Road site for future construction of the ventilation shaft and headhouse (the building that will sit on top of the vent shaft):
		• Grouting for ground water management;
		• Construction of piling platform at track level;
		• Concrete and tarmac ramp and piling platform to track level;
		 Network Rail cable and drainage installation; and
		 Installation of bored piling to establish foundations for the headhouse.
		To carry out these works, extended working hours may be required. We will provide further information to the local community about these

		works and provide updates about our ongoing works at the <u>in your area map</u> .
Location 2a Mandeville Road	Mid to end of September 2022	Utility surveys and investigations at Mandeville Road at the junction with the Mandeville Road vent shaft site compound, and Ealing Road and Belvue Road.
Location 2b Ealing Road / Belvue Road		Temporary traffic management, lane closures and bus stop suspensions will be in place for the duration of the works.
		These surveys will provide us with information on the condition of the existing utility services and help us to decide how best to protect them, ahead of tunnelling later this year.
Location 4 Carr Road and Cherry Gardens	September 2022 to January 2023	Ahead of the start of tunnelling later this year, we plan to complete major utility protection works at the Oldfield allotments on Carr Road and Cherry Gardens. The works consist of:
		 Installation of sewer lining. This will involve a temporary 24-hour 'over pumping' system to transfer water and control the sewage flow. This is to ensure your utility services are uninterrupted during construction. The function of the over pumping operation means it can be activated at any time within a 24-hour period to divert the flow of water if necessary;
		 Sewer and maintenance cover reinstatement works;
		 Installing a temporary haul road within the allotment's access road;
		• Site compound set up and hoarding installation to enclose our works area; and
		• Setting up a works compound and installing boundary fencing panels to secure our works on the Network Rail land, to enable the sewer protection works.

Location of works	Proposed duration	Description of works
Location 1 Mandeville Road site	Autumn 2022 to autumn 2023	 We will continue works to build the ventilation shaft in the Mandeville Road site: Diversion of Network Rail assets to allow construction of the vent shaft; Installation of a tower crane to assist construction of the vent shaft; Shaft dewatering (removal of water from ground as the shaft is constructed); Sheet piling for the basement and satellite shaft; and Excavation of the main shaft followed by segmental lining and spray concrete lining.
Location 3 Eastcote Lane	Spring 2023 to autumn 2023	We plan to complete major utility works on Eastcote Lane. We will be carrying out gas main installation and protection work in March 2023, following on from our survey works in July 2022. We will provide further information to the local community about these works before the works start early next year.

Respecting People, Respecting Places

Having listened to feedback from communities and stakeholders, we have refreshed our Community Engagement Strategy. <u>'Respecting People, Respecting Places'</u> highlights how we will always try to do the right thing and reduce disruption to the lives of local people as much as we can during the planning and building of the railway.

- **Consulting**: Formally consult with you while we seek permission to build Phase 2b (we now have permission to build Phase One and Phase 2a)

Our commitments to you

Informing

- We will tell you about HS2 works in your area.
- We have local community websites and newsletters with regular information and updates about our work in your area.
- We have local community teams who know your area. They will hold local events and run projects to keep you informed.

Involving

- We will involve you in opportunities to benefit and learn as we build HS2 including jobs, skills, education, employment and funding.
- We will ask you about the design of specific parts of the railway.

Responding

- Our dedicated HS2 Helpdesk is available 24 hours a day, every day of the year, to help with any questions or concerns you have about HS2 or our work.
- If things go wrong, we have a complaints process and a dedicated complaints team.
- An independent Construction Commissioner monitors how we manage and deal with complaints.

Consulting

- We will hold formal consultations with you while we seek permission to build Phase 2b of HS2.
- We now have permission to build Phase One and Phase 2a. This means we will only formally consult on this part of HS2 when we need permission to do things that fall outside the terms of the legislation agreed by Parliament.

Keeping you informed

We are committed to keeping you informed about work on HS2. This includes ensuring you know what to expect and when to expect it, as well as how we can help.
