High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci (BBV) is working on behalf of HS2 Ltd to build the new railway in your area.

Planned works along sections of A425 Leamington Road

Two-way temporary traffic lights are planned to be in operation along sections of A425 Leamington Road, as shown on location plan overleaf, from Monday 13 June 2022 until Friday 29 July 2022, 24 hours a day, each day, including weekends.

This is to allow us to carry out utility diversions ahead of the temporary re-alignment of the carriageway and to construct the green tunnel.

The temporary traffic lights are required 24 hours of the day due to open excavations at the side of the carriageway and to conform to current safety standards.

Please note the aforementioned dates are indicative and are subject to change at short notice.

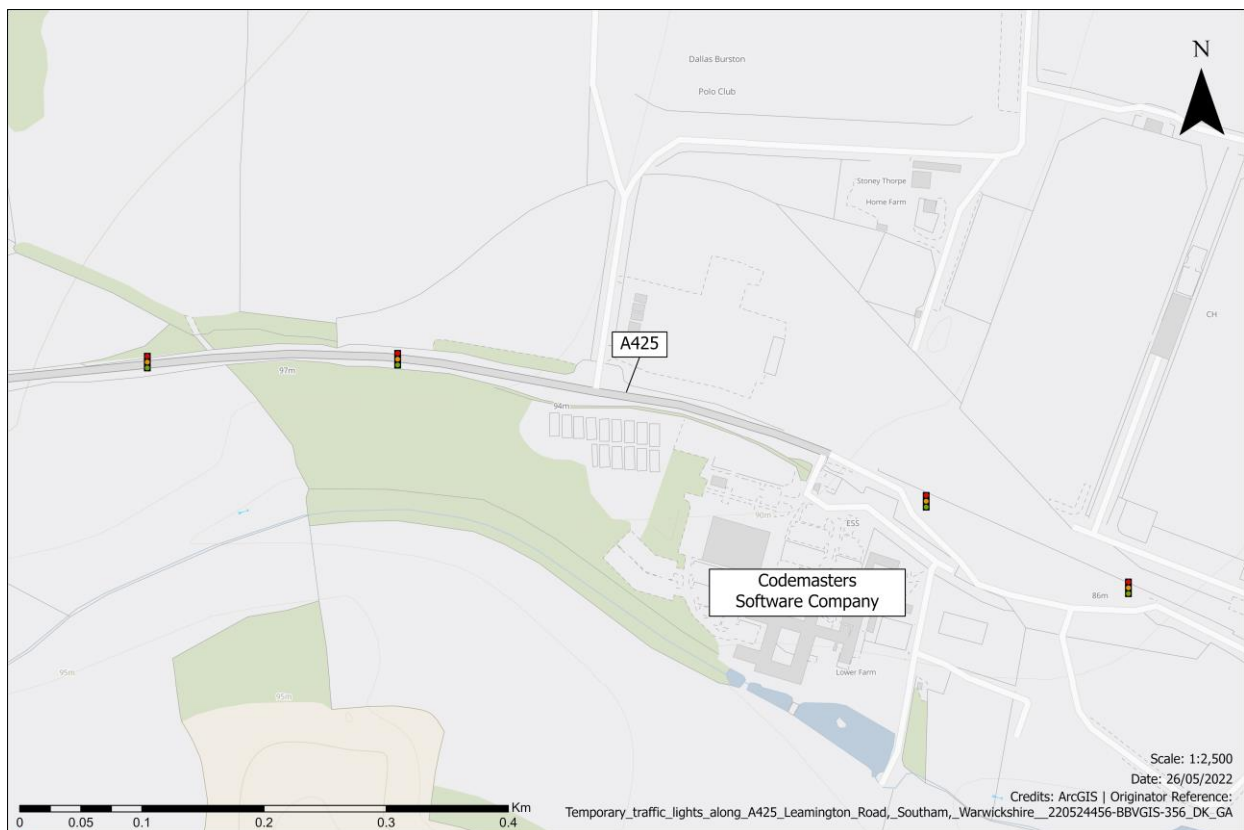
