



Notice of environmental works on land off Common Lane, Rileyhill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out Early Environmental works between Lichfield and Crewe.

What we are doing

As part of our early environmental works, we will establish critical environmental and species relocation sites creating new habitats for local wildlife before any main work starts.

We will be creating an area of grassland on land off Common Lane, surrounding an existing pond. We will use this area to relocate any protected species, such as Great Crested Newts before we need to remove any other habitats.

Before we start to construct the grassland habitat, we need to excavate some archaeological trial trenches. These are to help us understand if there are any archaeological features or natural geological deposits, that we need to be aware of before we start any other work. We will use a mechanical excavator to dig the trenches. No further excavation takes place at this stage.

When the work take place?

We will start the archaeological work on 05 July 2022. Later in the year we will plough, harrow, and seed the area with a wildflower seed mix, and plant a new hedge row.

The timeline for the works is shown below:

- Archaeological trial trenches – July '22
- Grassland creation - August to September '22
- Hedgerow planting – September to October '22
- Demobilisation - November '22

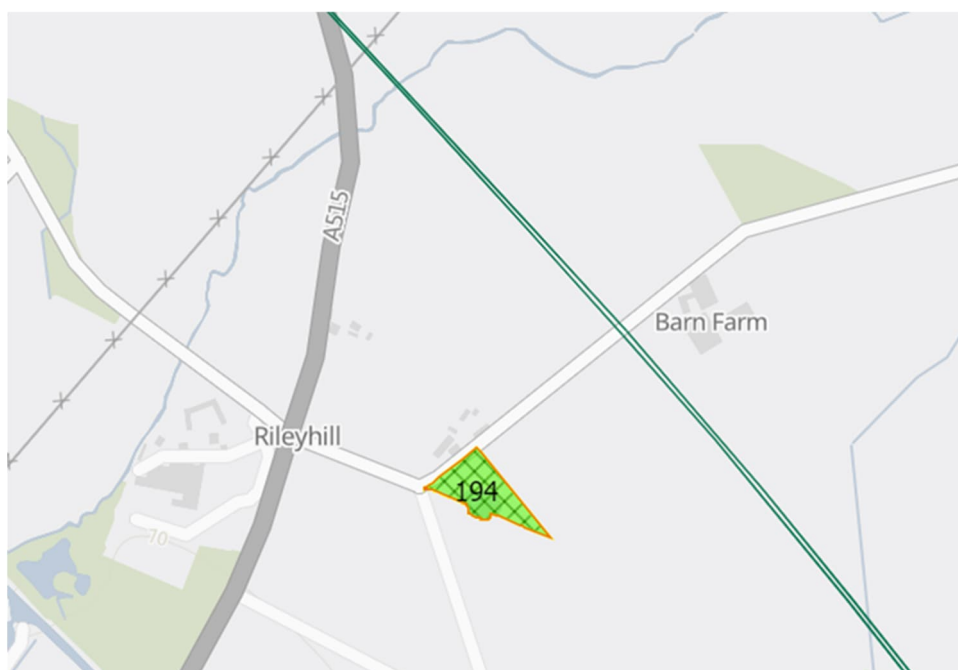

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
