## **Notice of Lane Closure on A446**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

#### The Work we will be doing

In order to build the new railway, the junction of the A446 (Stonebridge Road) and the A452 (Chester Road) is being significantly realigned. In preparation for this, we will be removing the concrete from the existing work area off the carriageway, filling the embankment, shaping the embankment slopes, and installing drainage. For the safety of our workforce and all road users we will need to close lane one of the northbound carriageway.

### When will these works take place

The lane will be closed between Monday 15 August and Friday 19 August from 8am to 6pm. Our workforce may be on site one hour before and one hour after to set up and secure our equipment.

#### **HS2 during the Coronavirus pandemic**

- Low levels of noise from the work we are completing.


