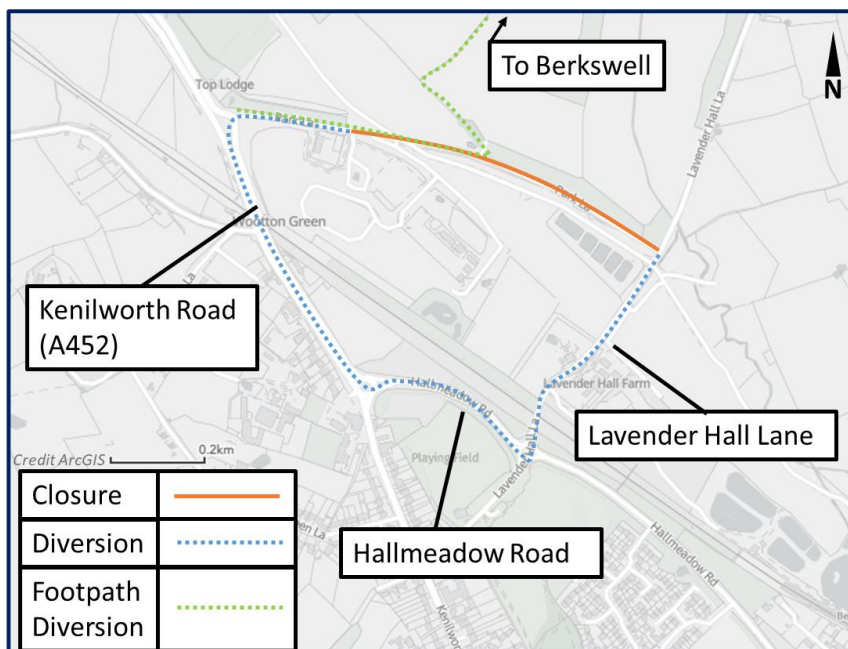
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

UPDATE

We previously contacted you to advise that Park Lane would continue to be closed until 1 July 2023. We now intend to keep Park Lane closed until the newly realigned Park Lane has been constructed in December 2025. Access will be maintained for residents and for walkers wishing to use footpath M214.

When these works will take place

BBV took possession of the road closure on 1 July 2022 intend to reopen a newly realigned Park Lane in December 2025. The road closure will be in place 24 hours a day including weekends.
