



## Notice of road closure update, Stratton Audley Road, Chetwode

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. The health and safety of our workforce and the communities we work within is our priority. ### What are we doing?

As part of our continued preparatory works for our internal haul and site access road we will be fully closing Stratton Audley Road, by School End, for approximately 5 days. BT Openreach will also be diverting a BT overhead line and moving it underground. To reduce disruption as much as possible, both BT and EKFB will work together under this closure, helping to minimise our impact on local communities.

We will be carrying out some localised vegetation clearance for our crossing point, where our internal road network will cross Stratton Audley Road.

For reasons of safety, we are required to close this section of road because we will be working along the verges and in close proximity to the carriageway.

### When will these works take place?

Stratton Audley Road will be fully closed, 24 hours a day, from Monday 27 June to Friday 1 July 2022, with a diversion route in place.

We will work to reopen the roads as soon as possible, to reduce disruption.

### Duration of works

Works will commence Monday 27 June 2022 for approximately 5 days.

24-7 full road closure.

Normal working hours:

Monday to Friday

8.00am – 6.00pm

Saturdays

8.00am – 1.00pm

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

### What to expect

Varied activities with both quiet and busier periods.

Full 24-7 road closure and some additional traffic.

Noise from plant and equipment used for the works.

### What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.

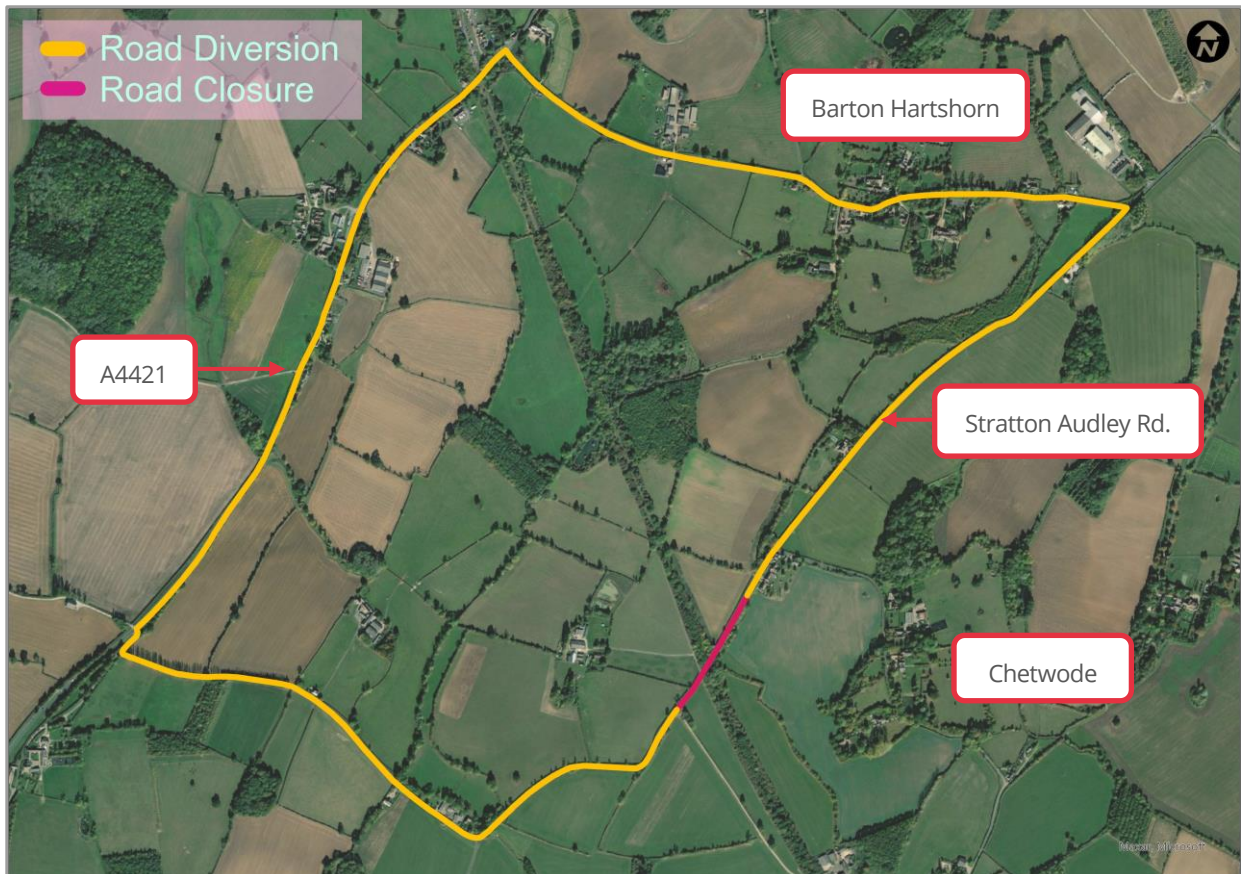
