



Update: Notice of environmental works on land off the A51, Swynnerton

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out early environmental works between Lichfield and Crewe.

What we are doing

In June 2022, we provided an Advanced Notice of Works to inform you about our work to create ecological mitigation ponds surrounded by grassland habitat creation on land off the A51 between Bottom Lane and Tittensor Road.

We will use the ponds to relocate any protected species, such as Great Crested Newts before we need to remove any other habitats.

We are nearing the completion of the creation of the ecological mitigation ponds and require filling them with water prior to the planting of the aquatic plants.

We will need to install temporary two-way traffic lights to manage the safe movement of the water tankers on and off site.

When the work take place?

We will put the lights place between from 10 October to 14 October 2022, 9am to 5pm.

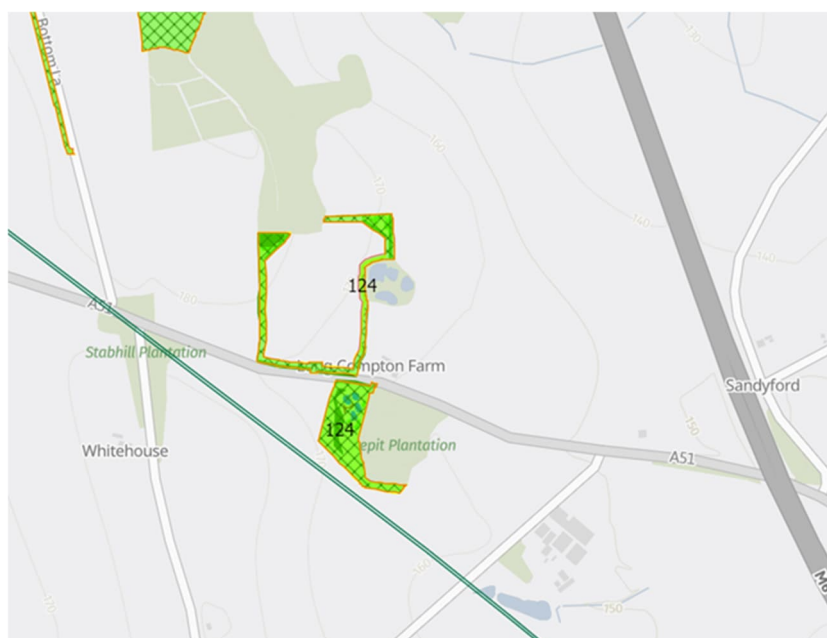

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
