High Speed Two (HS2) is the new high speed railway for Britain.

As we reintroduce face to face engagement, which is in addition to the ongoing virtual engagement, we will continue to follow government guidance on reducing the spread of Covid-19. What we are doing

In advance of tunnelling later this year, we need to drill boreholes and infill grouting to prepare the ground for tunnelling. This will take place from 23 June to 14 October 2022, Monday to Friday 24 hours a day.

We will use three drilling rigs, a dumper for moving muck away from the bore hole and an excavator.

Noise reduction fencing will be used at night, where possible, to reduce the noise levels.

How the work might affect you

The team will use electric powered lighting and machinery to reduce noise impacts on the local community.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.

We will use localised noise reduction fencing, where possible, to help keep noise to a minimum.
