



# Notice of road marking works on **Bottom House Farm Lane**

High Speed Two (HS2) is the new high speed railway for Britain. Some of the line markings on Bottom House Farm Lane near to Lower Bottom House Farm need to be replaced.

## What works are taking place

During the week commencing Monday 13 June, there will be one day's work to replace worn traffic markings on an area of Bottom House Farm Lane near to Lower Bottom House Farm. See picture below.

These works will take place between 8am and 5pm and vehicles using Bottom House Farm Lane will be managed through the works with operatives using Stop and Go boards. We anticipate the works themselves will only take half a day to complete.

Works are weather permitting which is why we are unable to indicate at this time the exact day when they will take place during that week.
