High Speed Two (HS2) is the new high-speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work will we be doing

To facilitate the building of the railway it will be necessary to divert the existing BT cables on Rugby Road.

To allow us to carry out these works safely Rugby Road will be closed from **Monday 11 July to Friday 15 July**. The closure will be in place off-peak from **9.30am to 3.30pm** each day. Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.

A fully signed diversion will be in place throughout this closure (please see overleaf).

Access will be maintained to all properties while these works are being carried out.
